# SCHEDULE A

## Leases

1. Lease to Rocky Mountain Natural Gas Company, Inc., a Colorado corporation, for a 30-foot right-of-way for ingress and egress in effect as long as the lessee maintains and uses its radio repeater site.

2. Business Lease to Pikes Peak Broadcasting Company, a Colorado corporation, for installation and maintenance of a television and radio broadcasting antenna and tower with an easement for ingress and egress dated October 4, 1978 and expiring approximately on June 30, 1999.
