ORDINANCE NO. 671

An Ordinance Appropriating Certain Sums of Money to Defray the Necessary Expenses and Liabilities of the City of Grand Junction, Colorado, for the Fiscal Year Beginning January 1st, 1944, and Ending December 31st, 1944.

Be It Ordained by the City Council of the City of Grand Junction, Colorado:

Section 1. That the following sums of money, or so much thereof as may be necessary, be and the same are hereby appropriated for the purpose of defraying the necessary expenses and liabilities of the City of Grand Junction, Colorado, for the fiscal year beginning January 1st, 1944, and ending December 31st, 1944, to-wit:

For General Bonds, Interest and Principal \$4,184.45
For Special Contingeng Fund 6,000.00
For Miscellaneous Fund 5,858.44
For Airport
For Engineering Department
For Health Department
For Fire Department
For Park Department
For Lighting Streets and Parks
For Public Benefit
For Highway Department
For Police Department
For General Office
For Force Account
For Cemetery Department
For Equipment Fund
For Library, Maintenance, Bonds and Interest
For Moyer Pool, Maintenance and Improvements 3,400.00

For Sewer Department, Maintenance, Improvements, Bond and Interest and Bond Sinking Fund 15,350.00

Total \$339,282.38

Section 2. That the amounts hereby appropriated for water bonds and interest and for the maintenance and improvements of the water system shall be provided for and paid out of the Water Fund.

That the amounts appropriated for Sewage Disposal Bonds and Interest and the maintenance of the Sewer Department shall be paid out of funds on hand in the Sewer Fund and from moneys collected for sewer rentals.

That the amount appropriated for the Equipment Fund shall be provided for from funds on hand in the Equipment Fund and from rentals charged on City equipment and gas tax refunds.

That the amount appropriated for Moyer Pool maintenance and improvements shall be paid out of the funds on hand in the Moyer Pool fund and revenue received from Moyer Pool for the year 1944.

That the amount appropriated for Cemeteries, shall be paid out of funds on hand in the Cemetery Fund and revenue received from the operation of the cemeteries in the year 1944.

That the amount appropriated for the Library shall be paid out of funds on hand in the Library Fund and the balance by levy on all property subject to local levy within the corporate limits of the City of Grand Junction, Colorado.

That the amounts appropriated for all other purposes shall be provided for by funds on hand and income from license fees, franchise tax and other miscellaneous receipts and by levy upon all property subject to local levy within the corporate limits of the City of Grand Junction, Colorado, as hereafter stated.

Section 3. The following amounts are hereby levied for the year 1944 to meet the necessary expenditures and liabilities of the City of Grand Junction, Colorado, for the year 1944, for the specific purposes indicated:

For General Fund (based on general fund appropriation) Fourteen and three-tenths mills (\$.0143) . . . \$120,437.93 For Library Fund -One and two-tenths mills (\$.0012) 10,106.68 Passed and adopted this 1st day of December, A. D. 1943. /s/ Glen L. Robb President of City Council
