ORDER APPROVING ELECTION RESULTS AND FOR DISSOLUTION OF THE DISTRICT

This matter comes before the Court on motion of the Central Grand Valley Sanitation District ("District") seeking an Order approving election results and an Order for Dissolution of the District. The court having reviewed the Motion and the attachments thereto, and after being fully advised in the premises, **FINDS**:

1. The question for Dissolution was presented to the qualified electors of the District at the general election held on November 6, 2012. The ballot question was administered by the office of the Mesa County Clerk and Recorder as a consolidated election in accordance with the provisions of Articles 1 through 13, Title 1, C.R.S., and Article 1 of Title 32, Sections 701 through 707, C.R.S. All statutory requirements have been complied with, met and performed.

2. The required Notice of Election was duly published in the Grand Junction Daily Sentinel, a newspaper of general circulation in Mesa County, Colorado, on October 30, 2012. Such Notice was done in compliance with this Court's Order Setting Election dated October 2, 2012, and in accordance with the requirements of C.R.S. 32-1-705. 3. The Office of the Mesa County Clerk and Recorder, Elections Division, issued the election returns as required by law which shows the election results to be as follows:

In Favor of Dissolution	-	5,862
Opposed to Dissolution	~	3,325
Total	-	9,187

The question passed with 64% voting in favor of dissolution and 36% voting against dissolution.

4. This court has proper jurisdiction over the subject matter of this proceeding.

THEREFORE, IT IS ORDERED AND DECREED:

A. The election results tendered to this court in the Motion filed by the District are in all respects approved and confirmed.

B. The Plan of Dissolution of the District is confirmed wherein all assets and operations of the District are to be transferred to and assumed by the City of Grand Junction. The District has no financial obligations or outstanding bonds.

C. The dissolution of the District shall proceed under the Plan of Dissolution and dissolution shall be final upon the filing of this Order with the office of the Mesa County Clerk and Recorder.
