#### **HEARING OFFICER MICHAEL GRATTAN**

#### I. CALL TO ORDER

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Michael Grattan, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson.

#### II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

- 1. Coffee House Holdings, Inc. dba Starbucks 11477, 2504 Highway 6 & 50, Suite 100, Grand Junction, CO 81505, Beer and Wine
  - No one was present representing the applicant. The renewal for Coffee House Holdings, Inc. dba Starbucks was found to be in order and approved.
- 2. Dillon Companies, Inc. dba City Market #51, 630 24 Road, Grand Junction, CO 81505, 3.2% Beer (Off-Premises)
  - No one was present representing the applicant. The renewal for Dillon Companies, Inc. dba City Market #51 was found to be in order and approved.
- 3. Bocaza Western Slope LLC dba Bocaza Mexican Grille, 644 North Avenue, Grand Junction, CO 81501, Hotel and Restaurant
  - Mr. Terry DeHerrera, Owner, was present. The renewal for Bocaza Western Slope LLC dba Bocaza Mexican Grille was found to be in order and approved.
- 4. Outback Steakhouse of Florida, LLC dba Outback Steakhouse #0621, 2432 Highway 6 & 50, Grand Junction, CO 81506, Hotel and Restaurant

No one was present representing the applicant. Ms. Heather Nara with Mesa County Health Department asked for a continuance on this renewal. Ms. Nara explained the applicant is in the Civil Penalty stage with several Health Department issues and she would like a continuance until August 3, 2016 for the applicant to get the issues resolved.

Hearing Officer Grattan asked Ms. Peterson to contact the applicant by certified mail to have them present on August 3, 2016, but if this item gets cleared up, they won't need to appear.

 Citrola's Italian Grill, LLC dba Citrola's Italian Grill & Bar, 625 Rae Lynn Unit C, Grand Junction, CO 81505, Hotel and Restaurant
 No one was present representing the applicant. The renewal for Citrola's Italian Grill, LLC dba Citrola's Italian Grill & Bar was found to be in order and approved.

#### III. APPLICATION FOR MODIFICATION OF PREMISES

 JUST BE, LLC dba Barons, 539 Colorado Avenue, Grand Junction, CO 81501, Tavern

Modification: Outdoor dining lease of 480 sq. feet to be added to the licensed premise.

Mr. Jon Baron, Owner, was present. Ms. Peterson reported the paperwork is in order, the applicant will be adding an outdoor dining area to the front of the building of approximately 480 sq. ft. Ms. Peterson said the applicant was granted the Outdoor Dining lease at the June 15, 2016 City Council meeting. The applicant was required to conduct and needs and desires survey for this modification. Ms. Peterson read the results into the record (see attached).

City Attorney Shaver asked Mr. Baron who conducted the survey. Mr. Baron said the two that were present with him who are Jasmine Vanderpool and Casey Knuepfer. City Attorney Shaver asked Ms. Vanderpool and Mr. Knuepfer if they heard the results Ms. Peterson read into the record and if they agreed with them. They both did. City Attorney Shaver asked what days and times was the survey conducted. Ms. Vanderpool said on the 28<sup>th</sup> and 29<sup>th</sup> and at different times during the day, and Mr. Knuepfer said on the 22<sup>nd</sup>, 27<sup>th</sup>, and 28<sup>th</sup>, again at different times during those days. City Attorney Shaver asked Ms. Vanderpool and Mr. Knuepher if they were compensated in anyway by the number of signatures obtained. Both answered no.

Hearing Officer Grattan asked if anyone was present in opposition of this modification being issued. There was no one.

Hearing Officer Grattan approved the modification for the outdoor dining lease to add the 480 sq. ft. patio to Baron's licensed premise.

#### IV. APPLICATION FOR SPECIAL EVENT PERMIT

 Western Colorado Botanical Society dba "Chilled by the River", 641 Struthers, Grand Junction, CO 81501 – July 29, 2016 from 6:00 p.m. to 9:00 p.m., Malt and Vinous

VP: Douglas S. Sorter, 349 Lilac Lane, Grand Junction, CO 81505 Event Manager: Honora Thompson, 381 W. Valley Circle, Grand Junction, CO 81507

Mr. Doug Sorter and Ms. Thompson were both present.

City Attorney Shaver provided both of them with three documents, the first two marked with an "A" and the third one marked with a "B" and asked Mr. Sorter if he has personal knowledge of those documents. Mr. Sorter said yes. City Attorney Shaver asked why these were completed. Mr. Sorter said as part of the paperwork for this Special Event application. City Attorney Shaver asked Mr. Sorter to describe the event and the area. Mr. Sorter said that Strive has partnered with United Way for a fundraiser. Mr. Sorter described the designated area which has permanent fencing on the grass area of the Botanical Gardens. Mr. Sorter also described the many events they have had at the same location. City Attorney Shaver asked if there have been any issues at these events. Mr. Sorter said no, that they have been successful since they have been having these. The band will be from 6:00 – 9:00 p.m. and ID's will be checked at the door and wristbands given to over 21 YOA. City Attorney Shaver asked Mr. Sorter whose signature is about halfway down the second page. Mr. Sorter said his. City Attorney Shaver asked Mr. Sorter to look at the page with the "B" in the upper right hand corner, and asked him to describe what the black line around the property represents. Mr. Sorter said that depicts the perimeter of the event and on a previous event, City Attorney Shaver had him outline it in heavy black marker. Mr. Sorter described that the event area is the same at each event and the attendees purchase the alcohol. Mr. Sorter said there will be two Citadel Security and three volunteers. City Attorney Shaver asked if he believed there would be between 200-400 people. Mr. Sorter said 300-400 would be his guess since this is the first year with this event and United Way.

Hearing Officer Grattan entered Exhibits "A" and "B" (see attached) into the record. He asked if there was anyone present in opposition of this application.

There was no one.

Hearing Officer Grattan found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event (it is a fundraiser), its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that the application for a special events permit submitted by Western Colorado Botanical Society dba "Chilled by the River" was in order and approved it.

#### V. APPLICATIONS FOR NEW LICENSE – RESOLUTION, FINDINGS, AND DECISION

1. Pink's BBQ, LLC dba Pink's BBQ, 1012 and 1014 N. 5<sup>th</sup> Street, Grand Junction, CO 81501, Hotel and Restaurant - **Continued from May 18, 2016** 

Member: Sharon Petty, 994 Kestrel Court, Grand Junction, CO 81501

Ms. Sharon Petty, Owner, was present.

Hearing Officer Grattan recognized there being numerous attendees in the audience and said he would like to start with Ms. Nara with Mesa County Health Department. Ms. Nara said there are still issues with non-compliance and the lack of a required hand sink; Mesa County Health Department is asking for a continuance for the application. Hearing Officer Grattan asked Ms. Nara when and if she believed Pink's BBQ would be able to come into compliance. Ms. Nara said she has asked for a construction schedule to be provided to the Health Department by July 12, 2016 and the hand sink to be installed by July 19, 2016, so until she sees this, she is uncertain.

Hearing Officer Grattan asked the audience if everyone in the room is either for or against this license being approved. There were nods of their heads in the affirmative.

Hearing Officer Grattan said he would begin by hearing from opposition to this license being used.

Mr. Frank Francese, 527 Belford Avenue, approached. Hearing Officer Grattan recognized Mr. Francese having numerous documents from him. He asked Mr. Francese to summarize the documents, not to read each one. Hearing Officer Grattan said he would read each one himself after this hearing but for Mr. Francese to explain to the Authority in his own words the issues. Hearing Officer Grattan marked each of the documents submitted as an Exhibit. They are A-H and entered them into the record.

Mr. Francese began by explaining his property, his business, how long he has lived there, past issues with a previous alcohol establishment, the small smoker, the large smoker, who he has contacted, his complaints, hiring Mr. Robert Traylor to represent him, his contact with Melissa Salter a County Pollution Department employee and Monique Mull with Mesa County Health Department, the neighbors he talked to, his attendance at the May 18<sup>th</sup> Liquor and Beer meeting for Pink's BBQ application for a liquor license, his health, and if this pollution does not stop, he will have to vacate his home for his health.

Mr. Robert Traylor, P.C. explained that he is here on behalf of his client, Mr. Francese, and he has filed a nuisance complaint under City Code Chapter 8.08 just this afternoon directed to Code Enforcement and the City Manager, and which City Attorney Shaver was copied on this. It is his hope for an investigation and resolution to this matter. Mr. Traylor has several suggestions for the Authority to solve this matter from moving the cooker, deny the application, and what the licensing Authority would be able to do.

Kristin Winn, representing local Citizens with Clean Air, explained that there are very few regulations that address outdoor BBQ smokers. If the smoker was indoors, there would be regulations to address the issues. It is her belief that as a City we need to protect our citizens.

Karen Sjoberg, Chair of Citizens with Clean Air, was present along with several others from this organization. She explained they are here to support Mr. Francese and there are definite issues with the noxious emissions and odors.

She agreed with Mr. Traylor's suggestions but would like to add one additional comment; if there could be mediation involved it would be a great idea.

Charlie Host, with Citizens with Clean Air, said he contacted the building department and found out a non EPA stove can be installed. His concern is for the carbon monoxide coming out of the smoker and or stove. He would encourage the business to work with the neighborhood.

Michael O'Boyle, 538 Teller Avenue, said he lives south of Mr. Francese and many nights they have to turn their swamp cooler off due to the odors. These are smaller lots, 50' x 125', in this area.

Hearing Officer Grattan asked Ms. Petty if she had an objection to the continuance. She said she did not. City Attorney Shaver asked Ms. Nara if the continuance until August 3, 2016 will give the applicant enough time to install the hand sink as this is a new situation and if Pinks BBQ is in civil penalty now. Ms. Nara said they have corrected 4 of the 6 critical violations, and paid a fine yesterday. This has not created an additional civil penalty.

Ms. Petty stated she is confused as why we are here today, she believed this to be a hearing for a liquor license, but with the other noxious odors, is this the right forum for this?

Hearing Officer Grattan explained that under his jurisdiction, he can only rule on the issuance of a new liquor license. But to rule on this, he explained the compliance issues for each agency are involved along with the needs and desires survey which he still has not heard those results. That is how he bases his decision on the issuance of a new and/or transfer of a liquor license.

City Attorney Shaver said if his office receives the complaint mentioned and if there is any other code enforcement issues from any other departments, his office will respond to those. City Attorney Shaver wanted to let those in attendance today to know that the Hearing Officer has not entertained the actual hearing process yet.

Hearing Officer Grattan asked Ms. Peterson to read the results of the survey conducted for Pinks BBQ into the record for the attendees to hear, but he still will not decide today (see attached).

Hearing Officer Grattan asked if there was anyone else in attendance who would like to speak for or against this issue.

Mr. Francese asked if there was nothing this Authority could do between now and August 3<sup>rd</sup> in regards to the business still being able to operate as normal. Hearing Officer Grattan and City Attorney Shaver explained the process and that this was the Authority just for issuing the liquor license.

Mr. Shawn Petty spoke in support of the BBQ restaurant. He said they are working hard to benefit the community by creating jobs.

Hearing Officer Grattan said he will make a decision on August 3, 2016 at the Liquor and Beer meeting to approve or deny this license.

#### VI. OTHER BUSINESS

1. Ms. Peterson reported there has been no contact from Hideaway Lounge to schedule the meeting the Authority requested of them. Hearing Officer Grattan asked Ms. Peterson to contact them so a time and date can be set up before August 2, 2016; if not it can be addressed at the August 3, 2016 Liquor and Beer meeting.

Just Be LLC filed an application with the Local Licensing Authority on June 9, 2016 for a modification of premises to add a patio area to the current hotel and restaurant liquor license permitting sales of malt, vinous, and spirituous liquors by the drink for consumption on the premises at 539 Colorado Avenue under the trade name of Barons. The application and supplementary documents were reviewed, found to be in order and accepted. The hearing date was set for July 6, 2016.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded on the North by Grand Avenue, South by South Avenue, 10<sup>th</sup> Street on the East, and 4<sup>th</sup> Street on the West and included both sides of the streets as the outer boundaries. The results of that survey are as follows:

There were nine responses that were disqualified due to being out of area and two with no addresses.

No letters of opposition or counterpetitions have been filed to date.

The Grand Junction Police Department will be investigating the owner for local criminal background check and that the diagram matches the establishment. Reports have been requested by the Grand Junction Fire Department, the Grand Junction Sales Tax Department, and Mesa County Health Department.

**Club = 1** (Grand Junction Elks Club)

**Brew Pub = 1** (Rockslide)



#### Dear Liquor Board Hearing

My name is Frank Francese and I reside at 527 Belford Ave in Grand Junction. I own the property and also have my business, Francese Watercolors, in my home. When I purchased the property 15 years ago I was told I could use it as a business if I live in the home at the same time. I purchased the property with the idea that when I retired I would have a studio to sell my work and conduct watercolor workshops to the public. For the last 15 years I travel 3 continents teaching watercolor painting. There were years I was gone for 30-35 weeks each year. I will have the home paid off this year and next year I will retire.

- We have a pollution/odor problem on Belford Ave. The odor problem is caused by Pinks BBQ meat smoker, located on the corner of 5th Belford Ave.
- The problem started on April 24, a Sunday, when they moved a commercial meat smoker on
  the property. Before they had used a smaller smoker, the exhaust from it was bad, but tolerable
  and we put up with the smell. Once the new smoker was up and running they started smoking
  meat 24/7. At night they would load it up and then leave. Leaving the neighborhood to deal with
  the smell and pollution.
- The smoke/odor from the exhaust is very nauseating, causing headaches and coating your sinuses with a fatty smell and taste. Some mornings there would be blood in my nasal discharge after a difficult evening of breathing the pollution/smell. On two different evenings I woke-up coughing and choking on the fumes and the odor was overwhelming!
- May 1, 2016, I contacted City Hall and was told to contact Code Enforcer, Mike Ferguson. I
  called and left a message. I even walked down to PD to see Mr Ferguson, I was told he would
  contact me. I received a call from Mr Ferguson and he stated he would look into the matter.
  Please look at the enclosed emails from Mr Ferguson and myself to understand the amount of
  communication between us.
- May 6, 2016 I returned home from the Art Center Auction around 9:15pm. I no sooner stepped out of car when I noticed the smell/odor, which was everywhere in my yard, once I opened my door to my house I found every room and all belongings were saturate with the odor. It was a miserable night with headaches, coughing etc. With each instance I would contact Code Enforcer and County Health. For the amount of complaints I filed there was less communications between myself and city and county officals.

- After the May 6<sup>th</sup> complaint I started marking my calendar on days when the odor was present. My house is affected by the direction of the wind that carries the smell. Some days we were OK, only smelling it occasionally during the day. Then Pink's ramped up the cooking/smoking and from May 27- June 13, the smell was overwhelming. I was in Denver the evening of June 9. Each day and evening the smell continued to invade my home, my clothes, my carpet and my body. On some days I see where I marked were very bad almost to the point of chocking on each breathe. I even tried to talk to Pink's about this. I walked over and asked for a manager and the man stated he was the manager. I stated the problem and his response was nill, nothing! He could care less about how his actions were affecting the neighborhood. I went over on two different occasions to try and reason with them and the last time the encounter escalated into a shouting match, that is when I walk off.
- The first week in June, with temperature hovering around 100\*, the smoke and smell was so bad I had to shut all windows and doors and turn off my swamp cooler. It was after 5pm, so I called Code Enforcer and County Health and left a message. I then called the PD and talked to a really nice lady. I told her the problem and she suggested I contact a County Commissioner.
- June 2, 2016, I wrote a letter to Commissioner McIinnis explaining the problem. He phone me stating he would look into the matter. The next day, June 3<sup>rd</sup>, he phone me and said he could do nothing after learning all enforcement is with the city, it had something to do with their Charter. He suggested I contact Rep Dan Thurlow and Senator Ray Scott.
- So, on June 4th I email both Mr Thurlow and Mr. Scott. The evening of June 15 there was a
  knock on my door and when I opened it, Rep Dan Thurlow was on my doorstep. Needless to
  say, I shocked that he would stop by. I explained the problem and he said he would look into the
  matter.
- June 13, I hired a lawyer, Robert Traylor, to help me with this mess. He contacted a City
  Council member and was told that any business discharging burning exhaust has to have a state
  pollution permit. He email the state and found that Pink's BBQ had no permit.
- I contact Melissa Salter at County Pollution Dept and filed a complaint. I was contacted by
  Monice Mull and she set up a meeting, June 14<sup>th</sup>, to hear the complain. Mr Traylor and I
  attended the meeting and I stated my complaint. We were told they would look into the matter. I
  even offer them my property to set up any pollution monitors to record the levels of pollution.
  To this day I have not heard back from them.
- After the meeting, I checked with my neighbors to see if they have been experiencing any smell
  problems. I found two homeowners with the same problem and mentioned they should write to
  County Pollution board with their complaints. The two homeowners have written their letters
  and sent them to Melissa Salter.

They are:

- Andy Fotopulos: 926 N. 5ht St, Grand Junction, CO 81501
- Scott Stoaks: 557 Belford Ave, Grand Junction, CO 81501
- This last weekend, July 2 and July 5th the cooking/smoking has continued, on Saturday June 2,
   I called Code Enforcer and County Health, again I got no response to my complaint.

I attended the May 18, 2016 meeting, at City Hall, for Pink's BBQ application for a Liquor License. I voice my objection to the application and told the board of my struggles with the pollution/odor problem. The residents and homeowners are objecting to the application for the following reasons:

- The smell and odor the cooking of the meat is affecting the health and well being of all
  residents on 5th and Belford.
- We are concerned how this will affect the value of our property when we sell.
- Liquor brings in crime, drugs and deviant behavior from the people visiting Pink's if they are given the application.
- A few years ago we had a liquor establishment on the corner of 5th and North Ave. It brought
  into the neighborhood all kinds of problems for us to deal with.
- I had to build a \$8000 security fence around my property to keep the drunks out, as they used my lawn for their antics. I would return home and find empty beer and whiskey bottles, used condoms, women panties, and used hypodermic needles, some still containing drugs. I even had a drunk fall through my bedroom window screen, late one summer evening. He cussed me for hindering his progress to get home!
- I submitted a petition to the City Clerk Office signed by myself and four other residents in objection to Pink's Application for a Liquor Licence.
- I am also concerned with parking as the patrons of Pink's will use my business parking in front
  of my home, leaving my patron's with no place to park while visiting my business.
- I am fighting for my home, my business and lastly, my health. I have experienced headaches, sinus discharge with blood, and a nauseating feelings in my stomach from the smoke. The smoke is colorless once it leaves the smoker and the only way to detect it is by smelling it.
   Please look at the pictures I have provided to see the discharge from the smoker.
- I will have to vacate my home if this pollution is not stopped. I will loose 15 years of work and
  my dream of a good retirement.

For the last 15 years I travel 3 continents teaching watercolor painting. There were years I was gone for 30-35 weeks each year. I will have the home paid off this year and next year I will retire.

We have a pollution problem on Belford Ave. The pollution is caused by Pinks BBQ meat smoker, located on the corner of 5th Belford Ave.. The problem started on April 24 when they moved a commercial meat smoker on the property. Before they had used a smaller smoker, the exhaust from it was bad, but tolerable and we put up with the smell. Once the new smoker was up and running they started smoking meat 24/7. At night they would load it up and then leave. The smoke from the exhaust is very nauseating, causing headaches and coating your sinuses with a fatty smell and taste. At this time I contacted City Hall and was told to contact Code Enforcer, Mike Ferguson. I called and left a message. I even walked down to PD to see Mr Ferguson, I was told he would contact me. I received a call from Mr Ferguson and he stated he would look into the matter. Please look at the enclosed emails from Mr Ferguson and myself to understand the amount of communication between

The first week in June, one evening the smoke was so bad I had to shut all windows and doors and turn off my swamp cooler. It was after 5pm, so I called Code Enforcer and County Health and left a message. I then called the PD and talked to a really nice lady. I told her the problem and she suggested I contact a County Commissioner. The next day I wrote a letter to Commissioner McIinnis explaining the problem. He phone me stating he would look into the matter. The next day he phone me and said he could do nothing after learning all enforcement is with the city, it had to do with their Charter. He suggested I contact Rep Dan Thurlow and Senator Ray Scott. So, on June 4ht I email both Mr Thurlow and Mr. Scott. The evening of June 15 there was a knock on my door and when I opened it Rep Dan Thurlow was on my doorstep. Needless to say, I shocked that he would stop by. I explained the problem and he said he would look into the matter.

At that time I hired a lawyer, Robert Traylor, to help me with this mess. He contacted a City Council member and was told that any business discharging burning exhaust has to have a state pollution permit. He email the state and found that Pink's BBQ had no permit.

So I contact Melissa Salter at County Pollution Dept and filed a complaint. I was contacted by Monice Mull and she set up a meeting to hear the complain. Mr Traylor and I attended the meeting and I stated

my complaint. We were told they would look into the matter. I even offer them my property to set up any pollution monitors to record the levels of pollution. To this day I have not heard back from them.

It was mentioned that I get more residents to write to County Pollution board with complaints, along with my complaint, two other homeowners have written their letters and sent them to Melissa Salter. They are:

Please check the emails to all the different folks, I have enclosed, so you can have a better idea as to the amount of time I have taken with this matter.

I attended the May 18, 2016 meeting, at City Hall, for Pink's BBQ application for a Liquor License. I voice my objection to the application and told the board of my struggles with the pollution problem. The resident homeowners are objecting to the application for the following reasons:

- · Liquor brings in crime, drugs and deviant behavior from the people visiting Pink's.
- A few years ago we had a liquor establishment on the corner of 5th and North Ave. It brought
  into the neighborhood all kinds of problems for us to deal with.
- I had to build a \$8000 security fence around my property to keep the drunks out, as they used
  my lawn for their antics.
- I am taking a petition around for the homeowners to sign in objecting to the application approve
  able.
- I am concerned with parking as the patrons of Pink's will use my business parking in front of
  my home, leaving my patron's with no place to park while visiting my business.

I am fighting for my home, my business and lastly, my health. I have experienced headaches, sinus discharge with blood, and a nauseating feelings in my stomach from the smoke. The smoke is colorless once it leaves the smoker and the only way to detect it is by smelling it. Please look at the pictures I have provided to see the discharge form the smoker.

I will have to vacate my home if this pollution is not stopped. I will loose 15 years of work and my dream of a good retirement.

Please help us in our struggle for clean air.

I contacted you a week ago with my concerns for the air quality here on the 5th St of Belford Ave. Across the street from my home is the restaurant Pink's BBQ. Two weeks ago they moved a large meat smoker on their property. Once it was up and running they started smoking meat during the day and all evening long. For the last year they were using a smaller version of smoker and the air quality was tolerable, we were able to live with the pollution.

Now, with the larger model of smoker, they are polluting the block of 5th Belford. I know the smoker is not to code as it should have a 10 ft stack to carry the smoke into the atmosphere, away from the houses on the block.

Last Friday evening I returned home around 9:30pm; I noticed a huge smoke present in my yard. Upon entering my home, as soon as I opened the front door I noticed each room was filled with the putrid smell of BBQ Pork and Beef. Having left the windows open for fresh air, I gave the smoke access to my home. I called your number and left a message concerning this problem. Each evening they start smoking around 8pm and it is all night long. Now, the last two mornings I have woke up and found blood in my handkerchief when I cleared my nose.

Gentlemen:

On behalf of my client, Frank Francese, 527 Belford Avenue, Grand Junction, CO 81501, this is a nuisance complaint under City Code Chapter 8.08 of the Grand Junction City Ordinances. Pink's BBQ, located at 1014 North 5<sup>th</sup> Street, Grand Junction, CO 81501 is creating an offensive smell by use of a meat cooker located on the north side of the building in which the business is located. The odor is so overwhelming that Mr. Francese believes the air in the vicinity of his home is unhealthy and that it is certainly "disagreeable to the neighborhood." Section 8.08-100(a) and (g), Grand Junction City Code.

Pink's BBQ installed the cooker in April 2016 and, since that time, Mr. Francese and his neighbors have experienced unpleasant and overwhelming odors associated with the cooker. Mr. Francese has attempted to resolve the matter with Pink's BBQ, but after contacting management three times without satisfactory response from Pink's BBQ, he decided to register his complaints with the City of Grand Junction and Mesa County. Mr. Francese has already made a formal complaint to Mesa County Health. The problem is summarized in Mr. Francese's letter to the Liquor License Authority dated July 6, 2016 and enclosed herein.

Mr. Francese would appreciate your prompt investigation and enforcement.

Grand Junction Liquor Board Hearing for Pink's BBQ Grand Junction City Hall 250 North 5th St Grand junction, Co 81501

#### Dear Liquor Board Hearing

My name is Frank Francese and I reside at 527 Belford Ave in Grand Junction. I own the property and also have my business, Francese Watercolors, in my home. When I purchased the property 15 years ago I was told I could use it as a business if I live in the home at the same time. I purchased the property with the idea that when I retired I would have a studio to sell my work and conduct watercolor workshops to the public. For the last 15 years I travel 3 continents teaching watercolor painting. There were years I was gone for 30-35 weeks each year. I will have the home paid off this year and next year I will retire.

- We have a pollution/odor problem on Belford Ave. The odor problem is caused by Pinks BBQ meat smoker, located on the corner of 5th Belford Ave.
- The problem started on April 24, a Sunday, when they moved a commercial meat smoker on
  the property. Before they had used a smaller smoker, the exhaust from it was bad, but tolerable
  and we put up with the smell. Once the new smoker was up and running they started smoking
  meat 24/7. At night they would load it up and then leave. Leaving the neighborhood to deal with
  the smell and pollution.
- The smoke/odor from the exhaust is very nauseating, causing headaches and coating your sinuses with a fatty smell and taste. Some mornings there would be blood in my nasal discharge after a difficult evening of breathing the pollution/smell. On two different evenings I woke-up coughing and choking on the fumes and the odor was overwhelming!
- May 1, 2016, I contacted City Hall and was told to contact Code Enforcer, Mike Ferguson. I
  called and left a message. I even walked down to PD to see Mr Ferguson, I was told he would
  contact me. I received a call from Mr Ferguson and he stated he would look into the matter.
  Please look at the enclosed emails from Mr Ferguson and myself to understand the amount of
  communication between us.
- May 6, 2016 I returned home from the Art Center Auction around 9:15pm. I no sooner stepped
  out of car when I noticed the smell/odor, which was everywhere in my yard, once I opened my
  door to my house I found every room and all belongings were saturate with the odor. It was a
  miserable night with headaches, coughing etc. With each instance I would contact Code
  Enforcer and County Health. For the amount of complaints I filed there was less
  communications between myself and city and county officals.

- After the May 6<sup>th</sup> complaint I started marking my calendar on days when the odor was present. My house is affected by the direction of the wind that carries the smell. Some days we were OK, only smelling it occasionally during the day. Then Pink's ramped up the cooking/smoking and from May 27- June 13, the smell was overwhelming. I was in Denver the evening of June 9. Each day and evening the smell continued to invade my home, my clothes, my carpet and my body. On some days I see where I marked were very bad almost to the point of chocking on each breathe. I even tried to talk to Pink's about this. I walked over and asked for a manager and the man stated he was the manager. I stated the problem and his response was nill, nothing! He could care less about how his actions were affecting the neighborhood. I went over on two different occasions to try and reason with them and the last time the encounter escalated into a shouting match, that is when I walk off.
- The first week in June, with temperature hovering around 100\*, the smoke and smell was so
  bad I had to shut all windows and doors and turn off my swamp cooler. It was after 5pm, so I
  called Code Enforcer and County Health and left a message. I then called the PD and talked to a
  really nice lady. I told her the problem and she suggested I contact a County Commissioner.
- June 2, 2016, I wrote a letter to Commissioner McIinnis explaining the problem. He phone me stating he would look into the matter. The next day, June 3<sup>rd</sup>, he phone me and said he could do nothing after learning all enforcement is with the city, it had something to do with their Charter. He suggested I contact Rep Dan Thurlow and Senator Ray Scott.
- So, on June 4th I email both Mr Thurlow and Mr. Scott. The evening of June 15 there was a
  knock on my door and when I opened it, Rep Dan Thurlow was on my doorstep. Needless to
  say, I shocked that he would stop by. I explained the problem and he said he would look into the
  matter.
- June 13, I hired a lawyer, Robert Traylor, to help me with this mess. He contacted a City
  Council member and was told that any business discharging burning exhaust has to have a state
  pollution permit. He email the state and found that Pink's BBQ had no permit.
- I contact Melissa Salter at County Pollution Dept and filed a complaint. I was contacted by
  Monice Mull and she set up a meeting, June 14th, to hear the complain. Mr Traylor and I
  attended the meeting and I stated my complaint. We were told they would look into the matter. I
  even offer them my property to set up any pollution monitors to record the levels of pollution.
  To this day I have not heard back from them.
- After the meeting, I checked with my neighbors to see if they have been experiencing any smell
  problems. I found two homeowners with the same problem and mentioned they should write to
  County Pollution board with their complaints. The two homeowners have written their letters
  and sent them to Melissa Salter.
   They are:

- This last weekend, July 2 and July 5th the cooking/smoking has continued, on Saturday June 2, I called Code Enforcer and County Health, again I got no response to my complaint.

I attended the May 18, 2016 meeting, at City Hall, for Pink's BBQ application for a Liquor License. I voice my objection to the application and told the board of my struggles with the pollution/odor problem. The residents and homeowners are objecting to the application for the following reasons:

- The smell and odor the cooking of the meat is affecting the health and well being of all residents on 5th and Belford.
- · We are concerned how this will affect the value of our property when we sell.
- Liquor brings in crime, drugs and deviant behavior from the people visiting Pink's if they are given the application.
- A few years ago we had a liquor establishment on the corner of 5th and North Ave. It brought
  into the neighborhood all kinds of problems for us to deal with.
- I had to build a \$8000 security fence around my property to keep the drunks out, as they used my lawn for their antics. I would return home and find empty beer and whiskey bottles, used condoms, women panties, and used hypodermic needles, some still containing drugs. I even had a drunk fall through my bedroom window screen, late one summer evening. He cussed me for hindering his progress to get home!
- I submitted a petition to the City Clerk Office signed by myself and four other residents in objection to Pink's Application for a Liquor Licence.
- I am also concerned with parking as the patrons of Pink's will use my business parking in front
  of my home, leaving my patron's with no place to park while visiting my business.
- I am fighting for my home, my business and lastly, my health. I have experienced headaches, sinus discharge with blood, and a nauseating feelings in my stomach from the smoke. The smoke is colorless once it leaves the smoker and the only way to detect it is by smelling it. Please look at the pictures I have provided to see the discharge from the smoker.
- I will have to vacate my home if this pollution is not stopped. I will loose 15 years of work and my dream of a good retirement.

Please help us in our struggle for clean air.

BBQ LLC dba Pink's BBQ, 1012 and 1014 N. 5<sup>th</sup> Street, Grand

Junction, CO 81501

Pink's BBQ, LLC filed an application with the Local Licensing Authority on April 19, 2016 for a new hotel and restaurant liquor license permitting sales of malt, vinous, and spirituous liquors by the drink for consumption on the premises at 1012 and 1014 N. 5<sup>th</sup> Street under the trade name of Pink's BBQ. The application and supplementary documents were reviewed, found to be in order and accepted. A copy was sent to the State Liquor Enforcement Division for a Concurrent Review. The hearing date was set for May 18, 2016. The Notice of Hearing will be given by posting a sign on the property on or before noon on May 4, 2016 and by publishing a display ad in the Daily Sentinel on May 4, 2016.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded on the North by Orchard Avenue, Grand Avenue on the South, 12<sup>th</sup> Street on the East, and 1<sup>st</sup> Street on the West and included both sides of the streets as the outer boundaries. The results of that survey are as follows:

Check, the <u>YES</u> column if you <u>SUPPORT</u> this type of license being issued because the <u>existing outlets do not adequately serve</u> the reasonable requirements of the designated area or check the <u>NO</u> column if you <u>OPPOSE</u> this type of license being issued because the <u>existing outlets adequately serve</u> the reasonable requirements of the designated area.

OPPOSE: 0

Residential Results: FAVOR: 51

OPPOSE: 0

There were 6 responses that were disqualified for the following reasons: 1 address was listed outside the survey area and 5 listed no address.

No letters of opposition or counterpetitions have been filed to date.

The Grand Junction Police Department will be investigating the owner for local criminal history and verifying that the Notice of Hearing was posted in a timely manner and that the diagram matches the establishment. The fingerprints were forwarded to CBI for further processing. Reports have been requested by the Grand Junction Fire Department, the Grand Junction Sales Tax Department, and Mesa County Health Department.

The number of liquor licensed outlets in the survey area are:

**Hotel and Restaurant = 4** (Old Chicago, Bocaza Mexican Grille, Fiesta Guadalajara, and El Tapatio)

Tavern = 1 (Volley's)

**Arts = 1** (Western Colorado Center for Arts)

**Retail Liquor Store = 1** (North Avenue Liquor)

**3.2% Beer (Off Premises) = 1** (Loco Food Mart #12)

**3.2% Beer (On Premises) = 1** (Pizza Hut #250)
