MINUTES WEDNESDAY, JULY 20, 2016, 2:00 P.M.

HEARING OFFICER MICHAEL GRATTAN

I. CALL TO ORDER

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Michael Grattan, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson.

II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

- 1. Vin Hospitality, LLC dba 626 on Rood Modern American Cuisine & Wine Bar, 626 Rood Avenue, Grand Junction, CO 81501, Hotel and Restaurant
 - No one was present representing the applicant. The renewal for Vin Hospitality, LLC dba 626 on Rood Modern American Cuisine & Wine Bar was found to be in order and approved.
- 2. Glacier Ice Arena, LLC dba Glacier Ice Arena, 2515 Riverside Parkway, Grand Junction, CO 81501, Beer and Wine
 - Robbie Koos, Owner, was present. The renewal for Glacier Ice Arena, LLC dba Glacier Ice Arena was found to be in order and approved.
- 3. Orange Coast Investments, Inc. dba Grand Vista Hotel, 2790 Crossroads Blvd., Grand Junction, CO 81506, Hotel and Restaurant
 - Debra Revis, General Manager, was present. The renewal for Orange Coast Investments, Inc. dba Grand Vista Hotel was found to be in order and approved.
- 4. CEC Entertainment, Inc. dba Chuck E. Cheese's, 2424 Hwy. 6 & 50, Grand Junction, CO 81505, Hotel and Restaurant
 - No one was present representing the applicant. The renewal for CEC Entertainment, Inc. dba Chuck E. Cheese's was found to be in order and approved.
- 5. Vega's Momma, LLC dba !sabroasa! restaurant, 122 and 124 S. 5th Street, Grand Junction, CO 81501, Tavern
 - Kari Boukhalfa, Owner, was present. Hearing Officer Grattan reported that he has represented Ms. Boukhalfa in a shareholder dispute in the past. City Attorney Shaver said he did not see any conflict. Ms. Peterson reported that

the Fire Department is asking for a continuance due to the panic bar not being installed. It has arrived per Ms. Boukhalfa, but not installed; she will contact the Fire Department for a re-inspection once it is completed. The rest of the reports are in compliance.

Hearing Officer Grattan granted the continuance to have this issue resolved. If it is resolved, the applicant will not have to re-appear and the renewal is granted.

6. Black Dog Grills, LLC dba Genghis Grill, 2474-C Hwy. 6 & 50, Grand Junction, CO 81505, Hotel and Restaurant

No one was present representing the applicant. The renewal for Black Dog Grills, LLC dba Genghis Grill was found to be in order and approved.

7. MALABO LLC dba GC Discount Liquors, 200 W. Grand Avenue #10, Grand Junction, CO 81501, Retail Liquor

No one was present representing the applicant. The renewal for MALABO LLC dba GC Discount Liquors was found to be in order and approved.

8. MZ Entertainment dba Thunder Struck Valley, 436 Main Street, Grand Junction, CO 81501, Tavern – **moved to the end of the agenda**

III. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES WITH LATE FILING

1. Albertsons LLC dba Albertsons Food Center #1886, 1830 N. 12th Street, Grand Junction, CO 81501, 3.2% Beer Off Premises – 16 days late

Robert Haynie, Store Manager, was present.

Hearing Officer Grattan admitted the letter from the applicant (Exhibit A) into the record for the explanation for the late filing; this was for both locations.

City Attorney Shaver asked if the letter from the tax department was correct and if they had submitted a change of address. Ms. Peterson said yes they have, and it is the tax department who processes the liquor license renewals.

The renewal for Albertsons LLC dba Albertsons Food Center #1886, 1830 N. 12th Street was found to be in order and the Hearing Officer Grattan found good cause for the late filing.

2. Albertsons LLC dba Albertsons Food Center #897, 2512 Broadway, Grand Junction, CO 81507, 3.2% Beer Off Premises – 16 days late

Robert Young, Store Manager, was present. The same was submitted for this store by the corporate office.

The renewal for Albertsons LLC dba Albertsons Food Center #897, 2512 Broadway was found to be in order and the Hearing Officer Grattan found good cause for the late filing.

IV. APPLICATION FOR SPECIAL EVENT PERMIT

Community Hospital Foundation Inc., dba "Tour of the Valley Bike Ride", 2351
 G Road, Grand Junction, CO 81501 – August 13, 2016 from 11:00 a.m. to 4:30 p.m., Malt, Vinous, and Spirituous

President: Dale Rooks, PO Box 727, Fruita, CO 81521 Event Manager: Craig Glogowski, 692 Poplar Ct., Grand Junction, CO 81507

Mr. Craig Glogowski, Executive Director of Community Hospital and Event Manager of this event, was present.

City Attorney Shaver provided four documents, the first two marked with an "A", the third marked with a "B", and the fourth page marked with a "C". City Attorney Shaver asked Mr. Glogowski if he has personal knowledge of these. He responded yes, he created them for this event. City Attorney Shaver asked Mr. Glogowski to describe the event. Mr. Glogowski said this is the 27th year for this bike ride, it is not a race. There are four different courses, he explained the reason the event is on Exhibit "C" which is the parking lot. They wanted it to be held in the grassed area indicated on exhibit "C" but the grass did not develop well this year, which has forced them to move to the parking lot where they did have this event the first and second years it was at the new hospital location. City Attorney Shaver asked if this is primarily a fundraiser. Mr. Glogowski said yes, this year they will donate back into the cycling community to the Concussion Task Force. City Attorney Shaver asked where the number of 475 came from. Mr. Glogowski said from past years attendance of about 440 participants, they hope to grow the event and hope they have 475 attendees. He was asked to explain how they plan on securing the event. Mr. Glogowski said they will use event taping along with flexible snow fencing to keep the perimeter of alcohol service contained.

Hearing Officer Grattan asked about question 12 of the questionnaire for Mr. Glogowski to explain what he meant. Mr. Glogowski said the vendors for the alcohol are Kannah Creek, Copper Club, and Redfox Cellars and they will have trained staff at their booths who have gone through either the City's seller/server training or a TIPS class.

City Attorney Shaver asked Mr. Glogowski whose signature that is on page two of the questionnaire. Mr. Glogowski said his.

Hearing Officer Grattan asked if there was anyone present in opposition of this Special Event application being issued. There was no one. Hearing Officer Grattan entered Exhibits A, B, and C into the record.

Hearing Officer Grattan found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special events permit, it would not be

injurious to the public welfare because of the nature of the special event (it is a fundraiser), its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that the application for a special events permit submitted by Community Hospital Foundation, Inc. dba "Tour of the Valley Bike Ride" was in order and approved it.

V. OTHER BUSINESS

 MZ Entertainment dba Thunder Struck Valley, 436 Main Street, Grand Junction, CO 81501, Tavern

Desda Casey, General Manger, was present.

Ms. Peterson reported the Fire Department and Sales Tax reports are in compliance. Mesa County Health Department is requesting a continuance and the Grand Junction Police Department (GJPD) reported there is a DUI, the conviction is pending, and a conviction of an assault in the third degree on one of the owners, Mark Towner. There is also one administrative action being reviewed by the City Attorney's office.

Hearing Officer Grattan asked Ms. Woodland with the GJPD to come forward on the administrative action. She said it has been sent to the City Attorney's office on the establishment.

Ms. Monique Mull, Mesa County Health Department described that the applicant is in the civil penalty process. They had 10 critical violations, upon reinspection; they still have 5 repeated violations which started the civil penalty process. Due to being in the civil penalty process, the Health Department must give the applicant time to come into compliance.

Hearing Officer Grattan asked Ms. Casey when she felt the establishment could be in compliance. She responded within a month.

Hearing Officer Grattan recognized that Mr. Tom Volkman was in the room along with Nicholas Mayle, Attorney for Ms. Casey. Mr. Volkman is present to represent Mr. Mark Towner, who indicated he hoped that one of the issues with Mr. Towner would resolve itself. Hearing Officer Grattan understood that the assault charge involved Ms. Casey and he did not want to cause issue having Mr. Towner present.

Hearing Officer Grattan said by continuance of this renewal until August 17, 2016, he hoped more information of the administrative action would be available and that the Health Department issue would be cleared up.

- 2. Ms. Peterson reported that the Outback Restaurant's health issues from the July 6, 2016 meeting have been cleared up.
- 3. Ms. Peterson asked Hearing Officer Grattan and City Attorney Shaver about the Hideaway Lounge and having the informational meeting at the ballroom at the

establishment, what they want to consider as the neighborhood for inviting them to this meeting. She explained for a planning application they use within 500', for a liquor license survey of the neighborhood it is typically a ½ mile in each direction, or it can be determined by a neighborhood. It was determined to just include the neighborhood behind the establishment. City Attorney Shaver said if they have an HOA to include them also. Ms. Peterson said she will create a mailing on this information and get this sent out.

- 4. Ms. Peterson advised that on August 17, 2016 there will be a Change in Corporate Structure for The Sports Vortex which will have Mr. Towner present and the review of Thunderstruck Valley with Ms. Casey here. Mr. Volkman said he and Mr. Towner could be outside until their item is called. Ms. Peterson will put the Change in Corporate for The Sports Vortex at the end of the agenda.




