- Randy has also received an email from a citizen who will be attending the August Forestry Board meeting to discuss elm seeds.

- Susan Carter offered to update the City of Grand Junction Parks and Recreation Tree and Shrub Guide, and will be creating a Xeric Guide.
- Susan Carter is in need of volunteers for the Arboretum and would like suggestions on how to obtain volunteers. The members provided ideas and input.
- Susan Carter put together a tour of the CSU gardens and Betty Ford Garden. Master Gardners and City Horticulture employees are planning to attend it on Sunday, July 10 and Monday, July 11.
