WEDNESDAY, JANUARY 4, 2017, 2:00 P.M.**

**HEARING OFFICER MICHAEL GRATTAN**

**I. CALL TO ORDER**

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Michael Grattan, City Attorney John Shaver, Deputy City Clerk Juanita Peterson, and Interim Deputy City Clerk Janet Harrell.

**II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

1. Brinker Restaurant Corporation dba Chili's Grill & Bar, 584 24 ½ Road, Grand Junction, CO 81505, Hotel and Restaurant

No one was present representing the applicant. The renewal for Brinker Restaurant Corporation dba Chili's Grill & Bar was found to be in order and approved.

2. Safeway Stores 46, Inc. dba Safeway Store #1533, 2901 F Road, Grand Junction, CO 81504, 3.2% Beer Retail (Off-Premises)

No one was present representing the applicant. The renewal for Safeway Stores 46, Inc. dba Safeway Store #1533 was found to be in order and approved.

3. Feather Petroleum Company dba Stop N Save No. Three, 723 Horizon Drive, Grand Junction, CO 81506, 3.2% Beer Retail (Off-Premises)

No one was present representing the applicant. The renewal for Feather Petroleum Company dba Stop N Save No. Three was found to be in order and approved.

4. Providence Project, Inc. dba MX Tapas Bar Restaurant, 546 Main Street, Grand Junction, CO 81501, Hotel and Restaurant

No one was present representing the applicant. The renewal for Providence Project Inc., dba MX Tapas Bar Restaurant was found to be in order and approved.

5. Walterscheid Investment & Consulting, Inc. dba All Pro Liquor, 2913 Patterson Road, #104, Grand Junction, CO, 81504, Retail Liquor Store

No one was present representing the applicant. The renewal for Walterscheid Investment & Consulting, Inc. dba All Pro Liquor was found to be in order and approved.

6. Volleys, LLC dba Volleys, 304/305 North Avenue, Grand Junction, CO, 81501, Tavern

No one was present representing the applicant. The renewal for Volleys, LLC dba Volleys, 304/305 North Avenue was found to be in order and approved.

7. VAT, LLC dba Jack Rabbit Liquor, 2681 Unawweep Avenue, Unit C & D, Grand Junction, CO, 81503, Retail Liquor Store

No one was present representing the applicant. The renewal for VAT, LLC dba Jack Rabbit Liquor was found to be in order and approved.

8. Namaste Nepal Restaurant, LLC dba Namaste Nepal Restaurant, 2692 Highway 50, Suites L & N, Grand Junction, CO, 81503, Hotel and Restaurant

No one was present representing the applicant. The renewal for Namaste Nepal Restaurant, LLC dba Namaste Nepal Restaurant was found to be in order and approved.

9. SAL, Inc. dba Fiesta Guadalajara-GJ, 710 North Avenue, Grand Junction, CO, 81501, Hotel and Restaurant

No one was present representing the applicant. All the reports are in compliance of the ones received but a report from the Health Department was not received. Hearing Officer Grattan approved the renewal contingent on a satisfactory report from the Health Department.

### **III. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES WITH LATE FILING**

1. Georgia Lu Lujan dba A Taste of Heaven Catering, 2817 North Avenue, Grand Junction, CO 81501, Tavern – 12 days late

Ms. Georgia Lujan was present. Ms. Peterson read the letter submitted by Ms. Lujan on the late filing (see attached). All the reports are in compliance.

Hearing Officer explained to Ms. Lujan that it is her responsibility to file in a timely manner and he hoped this did not happen again since this was her second late filing. Hearing Officer Grattan found good cause for the late filing and approved the renewal.

### **IV. APPLICATION FOR SPECIAL EVENTS PERMIT**

1. Grand Junction Lodge No. 270, Loyal Order of Moose, 567 25 ½ Road, Grand Junction, CO 81505, Malt, Vinous, and Spirituous, Grand Valley Baseball Texas Hold'em Tournament – February 11, 2017 from 1:00 p.m. to 5:00 p.m.

Administrator: George S. Fuoco, 612 Grand Valley Dr., Grand Junction, CO 81504

Event Manager: Andy Weaver, 499 Fremont St., Fruita, CO 81521

Both Mr. Fuoco and Mr. Weaver were present.

City Attorney Shaver handed Mr. Fuoco three documents. Two with an "A" in the upper corner and the other with a "B" in the upper corner (see attached). City Attorney Shaver asked Mr. Fuoco if he was familiar with these documents. He said yes, that he created them. City Attorney Shaver asked Mr. Fuoco if they have had this event in the past. Mr. Fuoco said no, but other Special Events at the Lodge. City Attorney Shaver asked Mr. Fuoco if there have been any issues with events in the past. Mr. Fuoco said yes, several years ago when they had fighting in the parking lot at an event. City Attorney Shaver asked Mr. Fuoco if this event is a fundraiser and what the funds will be used for. Mr. Fuoco said it is and for Grand Valley (GV) Youth Baseball. Mr. Fuoco said the "red" area on Exhibit "B" is inside the Lodge and this will be the only area this event will take place.

Mr. Weaver said it is a competitive event with only a drawing for prizes. This is the 4<sup>th</sup> year the GV Youth Baseball has held the event but the first time at the Moose Lodge. They only expect around 125 to 150 people.

City Attorney Shaver asked Mr. Fuoco where ID's will be checked. Mr. Fuoco said at the outside entrance door. Over 21 will be given a wristband but only over 21 will be allowed into the event to the Lodge. Mr. Fuoco said all officers and bartenders of the Moose have attended the City's Alcohol Server Responsibility Training. There will be six officers for the entire event.

Hearing Officer Grattan asked if there was anyone present in opposition of this Special Event. There was no one.

Hearing Officer Grattan found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special event permit, it would not be injurious to the public welfare because of the nature of the special event (it is a community event and fundraiser and held within a designated room in the Lodge), its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found the application for a Special Event Permit submitted by Grand Junction Lodge No. 270, Loyal Order of Moose, for the "Grand Valley Baseball Texas Hold'em Tournament- 2016" was in order and approved.

## **V. OTHER BUSINESS**

1. Hearing Officer Grattan said he has been appointed as a Judge of Division 8 in County Court. He will begin on the 23<sup>rd</sup> of January. He said the last ten plus years has been a pleasure serving as the Hearing Officer for the City of Grand Junction.

Both City Attorney Shaver and Deputy Clerk Peterson wished him well and said the pleasure was all theirs. City Attorney Shaver told Hearing Officer Grattan this would be his last meeting, that he would work on getting his replacement. He asked Ms. Peterson to call Alternate Hearing Officer Starritt to see if he was available for the next couple of meetings until a replacement could be obtained.


**To Whom it May Concern:**

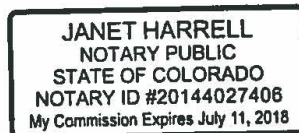

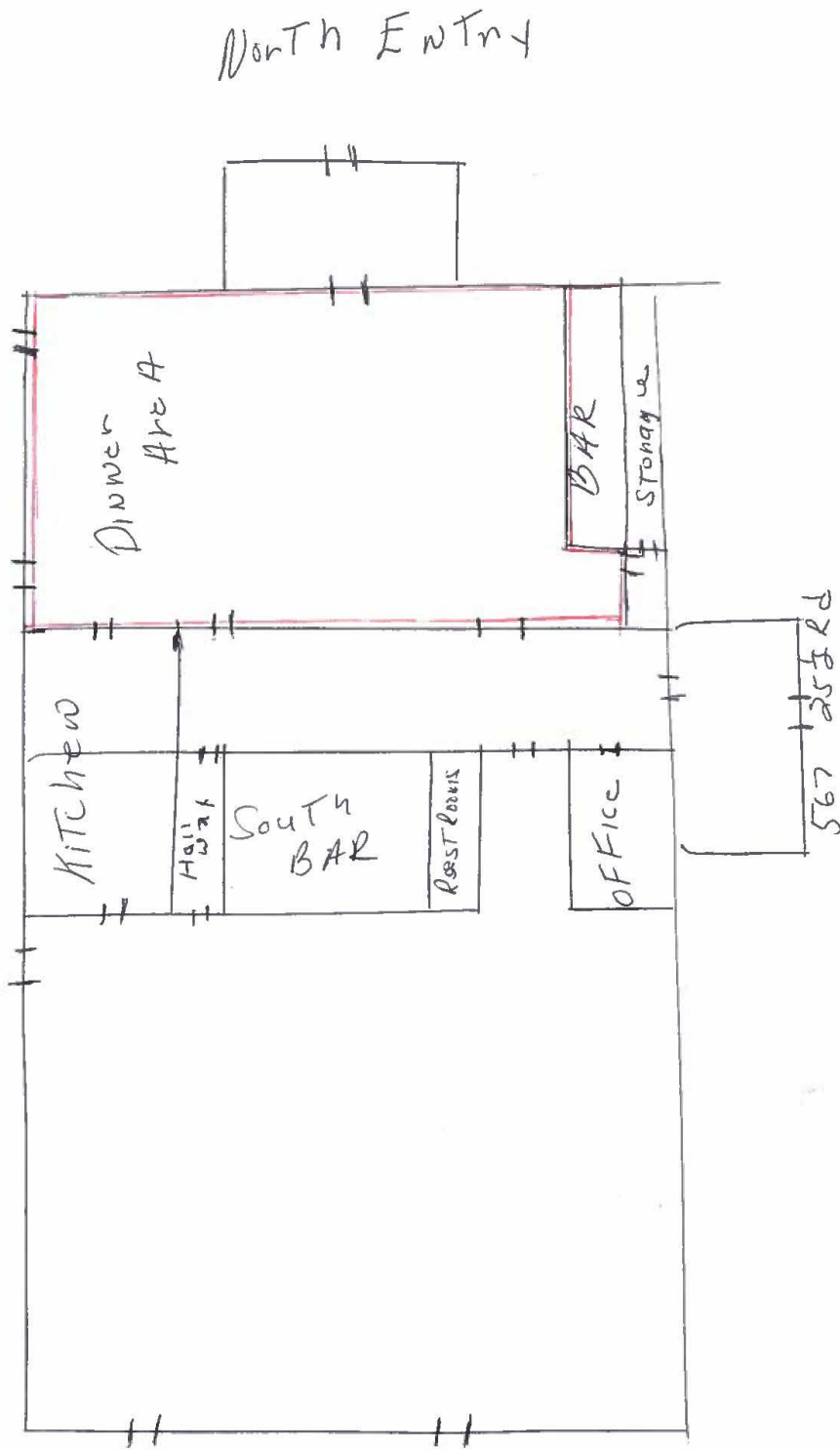
