I. CALL TO ORDER

The meeting was called to order at 2:02 p.m. Those present were Alternate Hearing Officer Sam Starritt, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson.

II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

No one was present representing the applicant. The renewal for Breckenridge Ale House GJ, LLC dba Breckenridge Ale House was found to be in order and approved.

Remove Todd Savoie and Sara Savoie as members, remaining member is Lizann R. Sinclair, 522 Main Street, Apt. D, Grand Junction, CO 81501

Lizann Sinclair was present. The renewal and change in corporate structure was found to be in order and approved.

IV. APPLICATION FOR SPECIAL EVENTS PERMIT

 Hilltop Health Services Corporation, 1331 Hermosa Avenue, The Beacon & Hilltop Senior Life Options Valentine's Dance – 2017, February 11, 2017 from 7:30 p.m. to 10:30 p.m. located at 625 27 ½ Road, Grand Junction, CO 81506

Nancy Jewel, Hilltop Representative, and Raquel Gustafson, Event Manager were present.

Ms. Peterson clarified with the applicant if it was "Dancey" or "Dance". Ms. Jewel said it was a typo, her fault, and it is "dance".

City Attorney Shaver handed Ms. Jewel three documents. Two with an "A" in the upper corner and the other with a "B" in the upper corner (see attached). City Attorney Shaver asked Ms. Jewel if she was familiar with these documents. Ms. Jewel said yes, that she completed them. City Attorney Shaver asked Ms. Jewel if they have had held this event in the past. Ms. Jewel said yes, for four years at the Commons.

City Attorney Shaver asked if the alcohol is incidental to the event. Ms. Gustafson said yes incidental, the main event is the dance with a live band. It will be in the main dining room. City Attorney Shaver asked if they have experience with checking ID's and serving. Ms. Gustafson said yes, and they have hired Fisher Liquor Barn employees to serve this event. She also said the age group for this event is at least 50 years of age.

City Attorney Shaver asked whose signature is on the second page of Exhibit A part of the way down. Ms. Jewel said Michael Stahl, who is the CEO of Hilltop Health Services Corporation.

Alternate Hearing Starritt asked if there was anyone present in opposition of this Special Event. There was no one.

Alternate Hearing Officer Starritt found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special event permit, it would not be injurious to the public welfare because of the nature of the special event (it is a community event and fundraiser and held within a designated room in the facility), its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found the application for a Special Event Permit submitted by Hilltop Health Services Corporation, for the "The Beacon & Hilltop Senior Life Options Valentine's Dance – 2017" was in order and approved.

Mr. Jason Steed said they would only be doing updates and cosmetic items that would not require a building permit or a final certificate of occupancy when they are finished. They are excited about a second location for the Roosters brand.

There being no one else in the room, Alternate Hearing Officer Starritt said he would approve the Transfer of Ownership from Robert J. Wilcox Inns dba as West Gate Inn to JMJ Ventures, LLC dba Roosters for a second location at 2210 HWY 6 & 50, Grand Junction, CO.

5. Describe the premises at which the event will take place.

The event will be held in The Commons of Hilltop - as assisted living facility owned by the Applicant and located at 625 27 1/2 Road. Specifically, The Garden Room and the Dining Room will be used for the event

6. What type of and how many security will be provided at this event and how will they be identified? Two members of Hilltop's staff will provide security for this event and will wear either vests or sashes that identify them as "Security".

7. What is the Control Plan for security at this even? (Use additional sheet if necessary) Hilltop staff as well as the employees of Fisher's Liquor Market who are responsible for serving the alcohol will check IDs, make sure anyone under age is not drinking and observe attendee behavior to detect any inappropriate, alcohol-related behavior. Taxis will be called for anyone deemed unable to drive themselves home.

8. How will security personnel be identified?

All security personnel will wear an identifying vest or sash.

9. If this event is being held outdoors, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?

The event is being held indoors.

10. What method will be used in checking identification for proper age of attendees (i.e., at the door, at the bar, etc.) and how will underage patrons be identified so as not to be served alcohol beverages (i.e., stamp or mark on the hand, etc.)

Staff from Fisher's Liquor Barn will be manning the bars and will be responsible for checking identification

for proper age attendees. While we don't expect any underage people to attend this event aimed at people 50 or older, we will stamp the hand of anyone who is underage.

11. How will the conduct and level of intoxication of attendees be monitored and by whom?

All staff will be alert for any signs of intoxication in our guests and the bartenders will be instructed to stop serving anyone who they believe is intoxicated.

12. Have the volunteers or members of your organization been trained in the sale/service of alcohol beverages?

Three members of Hilltop's staff have completed the City's seller/server training.

13. What types of alternate beverages and food/snacks will be available?

An array of hot and cold appetizers (including items made with bread and meat) will be served as well as a range of non-alcoholic beverages.
