I. CALL TO ORDER

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Sam D. Starritt, City Attorney John Shaver, and Deputy City Clerk Janet Harrell.

II. APPLICATION TO RENEW LIQUOR AND BEER LICENSES

- 1. The Noodle Shop, Co. Colorado, Inc. dba Noodles & Company, 2474 Highway 6 & 50, Unit A, Grand Junction, CO 81505, Hotel and Restaurant
 - No one was present to represent the applicant. The renewal application for The Noodle Shop, Co. Colorado, Inc. dba Noodles & Company was found to be in order and approved.
- 2. Sodexo America, LLC, dba Sodexo, College Center, 1455 North 12th Street, Grand Junction, CO 81501, Hotel and Restaurant with 3 Optional Premises
 - No one was present to represent the applicant. The renewal application for Sodexo America, LLC, dba Sodexo was found to be in order and approved.
- 3. Loyal Order of Moose Grand Junction #270 dba Loyal Order of Moose Grand Junction Lodge 270, 567 25 ½ Road, Grand Junction, CO 81505, Club
 - No one was present to represent the applicant. The renewal application for Loyal Order of Moose Grand Junction #270 dba Loyal Order of Moose Grand Junction Lodge 270 was found to be in order and approved.
- 4. High Plains Pizza Inc. dba Pizza Hut #248, 1440 North Avenue, Grand Junction CO 81501, Beer and Wine
 - No one was present to represent the applicant. The renewal application for High Plains Pizza Inc. dba Pizza Hut #248 was found to be in order with an exception from the Mesa County Health Department who asked that conditional approval be given pending a favorable re-inspection outcome. Continued to June 21, 2017 unless corrections are made and confirmed by Mesa County Health Department on or before June 16, 2017.

5. Donaldson Properties, LLC dba Junct'n Square Pizza, 119 N. 7th Street, Grand Junction, CO 81501, Hotel and Restaurant and Outdoor Dining Lease

No one was present to represent the applicant. The renewal application and outdoor dining lease for Donaldson Properties, LLC dba Junct'n Square Pizza was found to be in order and approved.

III. APPLICATION TO RENEW LIQUOR AND BEER LICENSE AND MODIFICATION OF PREMISES

 City of Grand Junction, dba Lincoln Park Sports Complex, 1307 North Avenue, Grand Junction, CO 81501, Tavern (Conversion to Lodging and Entertainment License)

Add the Lincoln Park Barn and Patio (south of the football field) to the licensed premises.

Larry Manchester, Recreation Supervisor, was present. The renewal and conversion application for City of Grand Junction dba Lincoln Park Sports Complex was found to be in order and approved.

Hearing Officer Starritt asked if the modification of premises application is complete. Ms. Harrell said the application to modify the premises and required survey is complete.

Max Scott, owner/operator of Oedipus, Inc., who conducted the survey for the modification of premises was present. Mr. Scott reviewed the survey methods, the defined neighborhood, and results (results and premises maps attached), and noted one signer was disqualified. City Attorney Shaver asked Mr. Scott how many years his business has been conducting surveys, how many surveys they have done, and if he had ever been asked to testify as an expert witness regarding survey work. Mr. Scott said Oedipus, Inc. is in its 49th year having conducted over 6,000 surveys and he has testified as an expert regarding survey work. City Attorney Shaver then asked Mr. Scott what his professional opinion of the survey is. Mr. Scott felt the modification should be granted as survey showed the needs and desire of the neighborhood are not being met.

City Attorney Shaver then asked Mr. Manchester to describe his relationship as Recreation Supervisor to the existing license. Mr. Manchester said his duties entail properly managing inventory (from purchase to service), ensuring all servers are trained, qualified, and that all aspects of alcohol service is in compliance. City Attorney Shaver asked Mr. Manchester if these practices would be extended to the Lincoln Park Barn and Patio if this modification is approved and if he knew of any alcohol service related issues. Mr. Manchester said yes, the same practices would be employed and he is not aware of any issues.

Hearing Officer Starritt asked if the alcohol is served only from the concession areas. Mr. Manchester said most of the sales are in the concession areas, but during some events mobile vending carts are used.

Hearing Officer Starritt asked if anyone would like to speak against the application. There was no one. He then said based on the information presented, the needs and desires of the neighborhood are not being met and approved the application.

IV. APPLICATION FOR NEW LICENSE - RESOLUTION, FINDINGS, AND DECISION

1. City of Grand Junction dba Las Colonias Amphitheater, 925 Struthers Avenue, Grand Junction, CO 81501, Lodging and Entertainment

City Manager: Greg Caton, 250 N. 5th Street, Grand Junction, CO 81501 Parks & Recreation Director: Rob Schoeber, 250 N. 5th Street, Grand Junction, CO 81501

Manager: Emily Krause, 250 N. 5th Street, Grand Junction, CO 81501

Emily Krause and Larry Manchester, Recreation Supervisors, were present. Hearing Officer Starritt asked Mr. Manchester to describe the location and layout of the proposed premises. Mr. Manchester described the general location, the proposed licensed area, and where the area will be secured with fencing. City Attorney Shaver handed Mr. Manchester a map of the area labeled "A" so he could point out the area, specifically the entrances/exits and fencing locations, which he did. Hearing Officer Starritt asked if the facility is still under construction. Mr. Manchester said the building is done and the "punch list" items are now being completed and the landscaping will be installed after those are completed. He added the first event in scheduled in early July. Hearing Officer Starritt then asked for the selling areas to be described. Mr. Manchester showed the permanently located selling areas on the map and said for the larger events mobile vending trailers with taps would also be used. City Attorney Shaver asked Mr. Manchester to explain the color coded areas. Mr. Manchester pointed out the storage areas (red), the restrooms (green), and the office area (blue) and noted for the larger events porta potty's will be placed within the proposed licensed area (outlined in black). City Attorney Shaver then asked how the licensed area would be secured and if the same practices Mr. Manchester said are used at the Lincoln Park Complex would also be used at this facility. Mr. Manchester said during events security guards would be employed to secure the entrances/exits, ID patrons over the age of 21, and provide them with wristbands and that the same practices he mentioned earlier would also be used at Las Colonias. Mr. Manchester added that the "B" map shows the fencing dimensions and location detail. Hearing Officer Starritt asked what type of fencing will be installed. Mr. Manchester said it will be a 6' vinyl coated chain link fence with four entrances/exits; some entrances/exits will not be used for smaller events, but they would still be secured.

Max Scott, owner/operator of Oedipus, Inc., who conducted the survey for the proposed lodging and entertainment liquor license for Las Colonias Amphitheater was present. Hearing Officer Starritt asked Mr. Scott to describe the survey area. Mr. Scott reviewed the survey area maps and noted the stark division made by the Colorado River between the predominant business (north area) and residential (south) areas and that due to the river, the population density of this survey area is notably less than what is typical. He then reviewed the results

(results and premises maps attached) and concluded, since there are currently no lodging and entertainment licenses within the survey area, the needs and desires of this area are not being met.

City Attorney Shaver asked Mr. Scott to expound on his remark that this neighborhood is "less dense". Mr. Scott explained the river takes up about 25% of the survey area and that there are not as many businesses or tenant occupied residences within the defined survey area as is typical; usually each comprise about 14% of the survey area. City Attorney Shaver asked Mr. Scott if the survey results were representative of this neighborhood even though it is not "typical". Mr. Scott said these results encompass a higher sampling than usual due to its makeup so these results are more representative of the neighborhood.

Hearing Officer Starritt asked if anyone would like to speak against the application. There was no one. He then said based on the information presented, the needs and desires of the neighborhood are not being met and approved the application. The City Clerk's office will prepare a resolution of findings and approval for the Hearing Officer's signature.

V. APPLICATIONS FOR SPECIAL EVENTS PERMIT

1. Rotary Club of Grand Junction – Horizon Sunrise, PO Box 459, Grand Junction, CO 81502 – "2017 Downtown Music Festival/Grand Junction Off-Road – Beer Garden", May 19, 2017 from 3:00 p.m. to 10:30 p.m. and May 20, 2017 from 10:00 a.m. to 10:30 p.m., between 3rd and 7th Streets on Main Street (beer garden portion only), Grand Junction, 81501, Malt and Vinous

President: Miquette Gerber, 324 Dakota Drive, Grand Junction, CO 81507 Event Manager: Kristi Adams, 390 Summer Glen Drive, Grand Junction, CO 81501

Miguette Gerber, President, was present.

City Attorney Shaver provided Ms. Gerber with three documents, two marked with an "A" and the other marked with a "B" and asked if she had personal knowledge of them and why she prepared them. Ms. Gerber said she was the one who prepared these documents, the Questionnaire/Affidavit and event diagram, as part of the completed application for a Special Events Permit on behalf of the Rotary Club so they could host the 2017 Music/Off Road Festival beer garden as a fundraiser. City Attorney Shaver asked Ms. Gerber if the Rotary Club had hosted similar alcohol service events. Ms. Gerber said they have hosted two similar events and several Club members have received alcohol server training through the City. City Attorney Shaver asked how the alcohol service would be conducted. Ms. Gerber said they will have a separate area to check/verify ID's, wristband those over the age of 21, and to purchase tickets for beer or wine. City Attorney Shaver asked what the expected attendance is. Ms. Gerber said based on past attendance numbers provided by the Downtown Development Authority, attendance for both days will be about 10,000. City Attorney Shaver then asked how the serving area will be secured. Ms. Gerber said there will be 14 entrances/exits that will be staffed with

volunteers ensuring no alcohol enters or exits the premises and three paid security guards will patrol the entire area; both will be present during the entire event. She added fencing will also be used around the perimeter of the event. City Attorney Shaver asked if that was her signature on Exhibit "A" and if her signature represented that the information on the questionnaire is true and correct. Ms. Gerber said yes.

Hearing Officer Starritt asked what paid security company they would be using. Ms. Gerber said it will be provided by Citadel and that they have provided security for this event before. Hearing Officer Starritt then asked if the 24 Rotary members who have received alcohol server training through the City would be in part or whole of the volunteer security. Ms. Gerber said the trained members will be stationed at the serving areas and the other volunteers will be used at other areas throughout the event such as the entrances/exits.

No one was present that opposed the application.

Hearing Officer Starritt admitted Exhibits "A" and "B" into the record (attached) and found that pursuant to Colorado Revised Statutes 12-48-106, there are no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event, its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. The application for special events permits submitted by the Rotary Club of Grand Junction – Horizon Sunrise for the 2017 Downtown Music Festival/Grand Junction Off-Road – Beer Garden was found to be in order and approved.

Foundation CEO: Liz Meyer, 710 Victor Drive, Grand Junction, CO 81506 Event Manager: Jennifer Stoll, 2101 I ½ Road, Grand Junction, CO 81505

Event Manager Jennifer Stoll and Crystal Manzanares, CMU Foundation, were present.

City Attorney Shaver asked Ms. Manzanares what her relationship is to this application since she is not listed as one of the applicants. Ms. Manzanares said she is representing CMU Foundation, the applicant for the permit. City Attorney Shaver then provided Ms. Manzanares with three documents, two marked with an "A" and the other marked with a "B" and asked if she had personal knowledge of them and why she prepared them. Ms. Manzanares said she prepared the complete permit application on behalf of the CMU Foundation and Greater Grand Junction Sports Commission for a fundraising event. Ms. Stoll described the events that will take place during the four day and said the beer garden will only be available on the final day of the event. City Attorney Shaver asked about the history of the event. Ms. Stoll said they have hosted the Maverick Classic (regional championships) before, but this is

the first time these national championships will take place in Grand Junction. She estimated about 1,000 people would attend any one day's events noting that this is a very weather dependent event. City Attorney Shaver asked Ms. Stoll if alcohol service is primary to the event or an addition to it. Ms. Stoll said it would be a nice addition to the atmosphere of the final day of the event.

City Attorney Shaver asked Ms. Manzanares to describe the security for the event. Ms. Manzanares said the perimeter of the event will be fenced and four Citadel security guards at the event, some at the entrances/exit to ID and wristband those 21 and over and all the alcohol servers will be TIPS certified. Ms. Manzanares said security guards will also be stationed by the 4th Street entrance (where two smiley faces are on the map). City Attorney Shaver asked Ms. Manzanares if that is her signature on the affidavit and if it represented that the information is true and correct. She answered yes.

Hearing Officer Starritt asked how many volunteers would be present. Ms. Stoll said at least 10 volunteers would be available at any one time. Hearing Officer Starritt asked where the serving area will be. Ms. Stoll said it will be where the third smiley face is closest to the Alpine Bank building.

No one was present that opposed the application.

Hearing Officer Starritt admitted Exhibits "A" and "B" into the record (attached) and found that pursuant to Colorado Revised Statutes 12-48-106, there are no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event, its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. The application for special events permits submitted by the Colorado Mesa University Foundation for the 2017 USA Cycling Collegiate and Para National Championship - Expo & Beer Garden was found to be in order and approved.

VI. OTHER BUSINESS

There was none.





Main Street Grand Junction will be blocked off to vehicle traffic so the event can take place between1st&7th					
Streets. The beer garden portion will only be between 3rd and 7th Streets.					
6. What type of and how many security will be provided at this event and how will they be identified? Two types of security will be used at the event: Paid Security and Volunteer Security. Paid security will likely be Citadel as they have been sucessful at the prior events. Volunteers will monitor entry/exit points only. 7. What is the Control Plan for security at this event? (Use additional sheet if necessary) See the attached layout. Volunteer Security will be at every entrance/exit to the beer garden to ensure no alcoholic beverages leave the area. Paid Security guards will roam throughout the event the entire time. Volunteer Security will prohibit alcohol from leaving the beer garden area. If patrons do not respond to the Volunteer Security personnel, Paid Security will be called to handle the patron.					
8. How will security personnel be identified?					
Paid Security will be in uniform. Volunteer Security personnel will wear like shirts or vests that will easily					
identify them.					
9. If this event is being held outdoors, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?					
Temporary fencing will be provided by You're Way Traffic Company and orange construction fencing will be					
used to secure the area where alcohol is sold as needed.

What method will be used in checking identification for proper age of attendees (i.e., at the door, at the bar, etc.) and how will underage patrons be identified so as not to be served alcohol beverages (i.e., stamp or mark on the hand, etc.) All people will be asked for proper identification as required by State law. The age identification table will be in a separate location from where alcohol is served. Tyvek wrist bands will be used to identify patrons over 21. 
