## Summary:

**2/2** – Crossroads Fitness/Compass Drive – a male subject armed with a knife tried to steal a backpack and jacket from a patron, subject was spotted in a nearby field and officers were able to contact him and locate the discarded knife; Best Buy/Hwy 6 & 50 – store was evacuated because employees could smell something burning, no cause for the smell was ever determined; Red Lobster/Hwy 6 & 50 – fire alarm was activated due to a power outage, this incident occurred during the same time as the Best Buy call; 3291 D ½ Road – unknown aged female was reported having a self-inflicted gunshot wound, the RP began the call stating her mother was sleeping with no mention of blood or weapons, then later became completely hysterical while on the phone with the call taker.

**2/4** – Woodspring Suites – a domestic dispute was reported, subjects were walking outside the address and a male fell into a hole, he was unconscious when officers arrived, subject was transported to St. Mary's C2; A 16 year old intoxicated female was contacted wearing a bear suit; 1305 Juniper – a large party turned in to a large fight; Fantasy Night Club – one male assaulted a female employee then left, the suspects name was provided but was not immediately contacted by law enforcement; 3144 ½ Goldeneye – 2 month old infant was dropped on his head, the RP was a neighbor who let the mother use their phone, mother was under the influence of some substance and returned in the system with multiple warrants, MCSO responded and advised the fall/drop was accidental.

**2/8** – 3687 G 4/10 road – two brothers got into an argument inside a pickup truck, the driver pushed the brother out of the vehicle, that male was caught under the vehicle while it started to move, the vehicle ran over his leg and broke it, the brother driving the truck was not contacted; 32 Road/Nottingham – a known male subject ran from a traffic stop in the area while handcuffed, was a wanted subject currently on pre-trial.

**2/9** – BOMB Squad responded to Montrose to assist the local Fire Department with an explosive device; a citizen from Montrose also called during this time to report finding blasting caps on his property, the BOMB team also assisted with that incident.

**2/10** – Bangs Canyon/Lemon Squeezer – a male subject fell from a rock, CareFlight responded and transported to St. Mary's, the male died at the hospital from multiple internal injuries; Paradise Hills Subdivision Park/Lanai Dr. & Bahamas Way – a 16 year old male was found with a self-inflicted gunshot wound to the head, the subject took his adult brother's gun from a vehicle and walked to the park; 609 W. Indian Creek – the Drug Task Force and US Marshal's Office arrested a wanted subject at the residence; Eagle Rim Park – an armed veteran was heard yelling that he was going to kill himself, he was upset with his country and was going to "shoot the police", officers located him at his residence and let him cool down, he called back hours later claiming he was being held against his will and made suicidal threats, was finally transported to St. Mary's without incident; Super 8 Motel/Horizon Drive – guests called in to report screaming and fighting, a male subject was choking a female, the female had fresh bruises and marks, the male subject was arrested; Dollar Tree/Rimrock Plaza – a male called in to report his intoxicated wife sitting in her vehicle in front of the business, the female was really angry and threatened to drive her car through the building, she was arrested without incident; MCSO Jail Employee Parking Lot – a male was seen on the jail security camera system in the fenced, locked employee parking lot, he went under the fence and was inside the gate, it was unknown at the time if he had vandalized any vehicles.

**2/11** – El Tapatio/North Avenue – a white Honda Civic was stolen, the keys were left in the vehicle; D ½ Rd & 33 ½ Rd – a vehicle crashed into a ditch, one patient was transported with injuries; Cabela's/Hwy 6 & 50 – two subjects were breaking into vehicles, the owner of one vehicle confronted the suspects, then the suspects punched the owner in the face, both suspects were caught in the area and arrested; 29 Mile Apartments/A Building – subjects were fighting and one male kept taking a gun out of the holster, the male was arrested.

**2/12** – 1240 Glenwood – a neighbor reported hearing a female screaming about an overdose in the residence below them, when officers arrived on scene a male subject was found unconscious with agonal breathing from a heroin overdose, Narcan was given and he was transported to St. Mary's; 2845 B 3/10 Road – 25 year old female delivered a baby in the bathroom of the residence, this was the female's third pregnancy, the grandmother who called 911 did not know the female was pregnant and the female indicated she had only known for a month, both mom and baby were doing well and were transported to the hospital; 28 ¼ Rd – a known male subject was found in a small amount of water at the bottom of the canal, he had fallen in the night before and was unable to get out, the male was transported to St. Mary's with two broken legs; Gunnison River near the PD Shooting Range – a highly intoxicated 73 year old male reported his genitalia was cut off by an unknown subject, the male and his genitalia were located and he was transported to St. Mary's C2, the GJPD opened an investigation, suspects were not located.

**2/13** – 547 29 ½ Rd #2 – 61 year old female found deceased between a bed and dresser, the RP was a CPS case worker who was doing an unannounced home visit on a juvenile in the woman's care, MCSO opened an investigation and took one juvenile female in to custody; 125 Franklin – 25 year old male fell from a second story balcony, subject was taken to St. Mary's C2; Sears/Hwy 6 & 50 – two males were loading bags with merchandise, one male had a handgun in his waistband, the subjects separated and left, officers contacted the vehicle at Best Buy and both subjects were detained; Murdoch's – two vehicles were reported driving erratically, one driver indicated to deputies their home had been robbed

and he was following the suspects, two males fled from the other vehicle on foot and were detained after a short foot pursuit; 3284 ½ D ½ Rd – a chair caught on fire, one patient was transported to St. Mary's, three people and four pets were displaced; 3226 ½ Rood Ave #4 – suicidal female was threatening to hang herself, posted pictures on Facebook with a rope around her neck, MCSO responded and could see the female with the rope around her neck, and the rope attached to the ceiling, deputies forced entry into the residence, the female was very intoxicated and transported to St. Mary's – This same subject called earlier and asked for law enforcement to come and take her three children because she was afraid she'd hurt them, the father picked up the kids from the residence before the suicide attempt occurred; 541 Pearce – a male subject was assaulted with a metal t-ball bat, was hit in the head several times, a suspect was not immediately contacted.

**2/14** – 284 28 ½ Rd – a burglary in progress was reported, one female and one male were taking things from a residence, deputies arrived and the female subject got into the back of the patrol car on her own, she was later released and the incident was changed to a suspicious; 30 Rd & D ¼ Rd – an 18 month old female was found wandering in the area barefoot and in her pajamas, officers arrived and called CPS, the father showed up 15-20 minutes later; 145 30 ¾ Rd – a fire started in the home and spread to the swamp cooler, there was smoke throughout the mobile home but it was not a complete loss; 1434 Rood Ave – residents came home to their front door kicked in and blood all over the floor throughout the residence, officers entered the home and found a male subject with a knife to his throat who began cutting when contacted, tasers were deployed several times and subject had severe lacerations to his throat and arms, the GJFD transported the subject to St. Mary's C3.

**2/15** – 6<sup>th</sup> and Ute Ave – at 0710 two chickens were reported running loose in the parking lot of the address, the chickens would repeatedly seek shelter underneath a red truck parked in the corner, but kept venturing into the roadway, a shift supervisor communicated what was happening to staff in the room and one telecommunicator indicated those were most likely her chickens that had roosted on the leaf springs of her red truck, she had unknowingly brought them to work with her, the TC and two of her coworkers just getting off their graveyard shift went to the parking lot and attempted to catch the chickens, a State employee and one PD officer decided to join the fun and also started chasing the two chickens, the shift supervisor also decided to lend a hand and recruited an IT employee to help out, finally with the help of seven individuals and several minutes later, both chickens were safely captured and put back in the TC's truck where they waited for a ride home.

**2/16** – 24<sup>th</sup> & Gunnison - a male subject darked out his vehicle and fled when PD officers attempted to contact him, the vehicle crashed at 281/2 & North Ave, the subject had a bandana over his face and handcuffs in his lap, driver had to be extricated with a head injury, possibly intoxicated; Hwy 50/mile marker 40 – fatal vehicle crash, one patient with a broken arm and the other was DOA; Clifton Best Western – 70 year old female passed out in the bathroom was deceased when responders arrived; Grand Jct High School – a fire alarm was triggered and staff on scene stated there was smoke in the building; responding officers found toilet paper on fire in a bathroom, the fire was quickly extinguished and juvenile male was taken in to custody relating to the incident; 12<sup>th</sup> & Grand Ave – two vehicle crash that ended in a residents yard, northbound and southbound traffic was shut down for an extended period of time.

**2/17** – Hwy 65/mile marker 46 – head-on, rollover motor vehicle crash, minor injuries and one subject extricated from the vehicle, CSP/MCSO/Collbran Marshal and PVFD responded.

**2/18** – I-70/mile marker 58 – subject rolled their vehicle and told the parties on scene with him that he did not want to live any longer, the male had cuts to his arms; 415 S 3<sup>rd</sup> St #502 – a 62 year old male collapsed and died; 1700 Ptarmigan Ridge Circle – a 70 year old female was found deceased by her husband; 49064 KE Rd – MSCO responded to a known suicidal subject, have responded to this subject in the past for suicidal threats, the male had a gun in his mouth when deputies arrived to this incident.

**2/19** – Dry Forks Campground – a couple with a baby got their vehicle stuck in the snow, their family drove to the area to help the couple and ended up getting stuck as well, both parties were located by

SARC without further issues; Multiple suicidal subjects reported, none resulting in death; 340 Northridge Dr. – a male and female were fighting over a 14 month old child, the child was removed by CPS after neither parent would leave the residence for the night; 1<sup>st</sup> Street/Andy's Liquor – two separate glass break alarms were triggered, the business had been broken in to but no one was found inside when officers responded, unknown at the time if anything was stolen.

**2/20** – 332 Sienna Court – a male subject was having a mental break down, the subject has history of psych issues, officers responded and the subject was transported by his daughter in a personal vehicle; 606 Peace Dr. – a subject was assaulted and had an injury to the back of their head, the RP was not cooperative and waited 15 minutes to call 911; 1622 11 8/10 Rd – a juvenile sent a text message to a friend indicating they were going to commit suicide, then a few minutes later the subject got back online with the RP and started playing Xbox Live; 2035 Wrangler Way – the RP found their brother dead after he had been sick; 389 White River Dr. – construction workers found subjects staying in the attic at the address, the subjects refused to leave, the GJPD and Clifton FD responded and deployed gas inside the home, nobody was found in the attic once the gas cleared; 3199 Mesa Ave/C & F Food Store – an ex-employee and her husband stole bread and soda from the location, deputies arrived and requested C3 backup, they had two at gun point and one subject fled from the area, that subject was tased and the other subject was taken into custody, the male subject that was arrested had four warrants; Hwy 50 & Siminoe Rd. – a female was reported being pushed inside a vehicle after running from a male subject, MCSO responded and coordinated with Delta County SO, the vehicle was contacted at a local fast food business, the subjects were father and daughter and the situation was C4.

**2/21** – 530 Rosevale Dr. – a female resident was approached by two males wearing masks holding guns while she was taking out her trash, the subjects stole the females vehicle, phone and guns.

**2/22** – 396 Monument Rd. – two subjects who were hired to replace siding at the residence started arguing and one subject threatened the other with a hammer.

**2/23** – Devin Dr. & Kay St. – two males were taken into custody after multiple vehicles and garages were burglarized, suspects were in possession of a stolen handgun that was taken from a truck the day before; 254 Beacon Ct. #2 – Adams County called to assist with a stolen auto from their jurisdiction, the SO responded three separate times and the house was also being surveyed by the GJPD for unrelated activity, unknown outcome of incident.

**2/24** – Motel 6/Horizon Dr. – MCSO contacted a wanted subject without incident and arrested him on a no bond warrant for parole violation out of California; 2828 Walker Field Dr. – a C560 Citation had landing gear issues, four souls were on board and the aircraft was able to safely land without incident; 455 Prairie Fire St. – a suicidal male left the address with a gun, his phone was traced to Olathe, Montrose County was contacted and confirmed the vehicle had just crashed into a tree and was fully engulfed, the male did not survive.

**2/25** – 447 N Sherwood Dr. – 18 year old male broke two of his grandmothers phones and threw a brick through the window of her vehicle, the male subject was taken to Mind Springs; 31 ½ Road railroad crossing – a semi-truck got stuck on the tracks and had to be towed, all trains were stopped during incident; 585 25 ½ Rd. #58 – an unattended death was reported, the RP notified family and waited over an hour before calling 911 for help; 1024 P Road – 84 year old male was found deceased outside the address; 2816 Meade Ct. – 17 year old autistic male made suicidal threats and was taken to Mind Springs; 829 Hall Ave. – a female stabbed her boyfriend in the head with a serrated knife, the female was not immediately contacted; Thunderstruck Valley – multiple fights reported and two subjects that were contacted outside the business had active warrants, use of force was required to detain both males; American Best Value Inn – a stolen rental car out of Denver was found at the address, the vehicle was associated to a murder suspect from Denver.

**2/26** - I-70/mile marker 191 – a subject called in on a non-emergent line and said he was having a stroke, the call taker stayed on the line with the subject and transferred the call to Grand County, Lower Valley FD was dispatched and CareFlight was paged, Grand County EMS cancelled Lower Valley when

they arrived on scene, but called them back 40 minutes later to assist with the same patient, the patient passed away before Lower Valley arrived back at the scene – one hour and 45 minutes after the initial call; 421 N Gemini Cir. – 14 year old male was hit with a bat by his father for not cleaning his room, it was later determined that the juvenile was lying and was upset with his parents after being punished for not following their rules.

**2/27** – 1811 Red Sandstone Rd. – a subject was assaulted and had a gun pulled on him because the HOA's issue with the homeowner building a shop, several civil issues in this neighborhood have been reported in the past, one subject was taken into custody and another subject was transported to St. Mary's; 371 Bean Ranch Rd. – two trees were on fire, Lands End FD responded and closed the road for a period of time; 860 4<sup>th</sup> Ave./Castings – a verbal argument was reported, one subject then pulled out a gun, officers arrived and had one subject at gun point, then in custody without further incident; 626 Clearwater Ct. – 32 year old female found deceased; Fantasy Night Club – an intoxicated male subject threatened bouncers and left the address in a vehicle, rolled the vehicle at Hwy 6 & 50 & North Ave.
