The Meeting was called to order and 2:00 pm. Those present were Hearing Officer Starritt, City Attorney John Shaver and Deputy City Clerk Janet Harrell.

Event Manager Miquette Gerber was present.

Hearing Officer Starritt asked Ms. Gerber who she represented and what entity had submitted the application for the Rock and Raft Beer Garden. Ms. Gerber explained she was with the Rotary Club. City Attorney Shaver provided Ms. Gerber with two documents, marked with an "A" and "B" and then asked on whose behalf the application was submitted. Ms. Gerber said it was on behalf of the Rotary Club.

City Attorney Shaver noted, Exhibit A, the application questionnaire, showed this would be the event's second year. Ms. Gerber pointed out that this is the 4th Rotary event and all have been successful thus far with no violations. City Attorney Shaver then asked Ms. Gerber to describe how the alcohol service will be conducted. She responded that they will ensure that trained club members are serving and ensuring lawful service through verifying state issued identifications and passports. Wristbands will be issued and servers will ensure that no one is drinking without one.

City Attorney Shaver asked Ms. Gerber to describe the venue on Exhibit B, the event diagrams. Ms. Gerber explained that the event will be at the old amphitheater at Las Colonias Park. The event will be a fenced area with one entrance/exit for the beer garden. Security guards will be posted at the entrance/exit checking wristbands outside of the entrance/exit to make sure people with wristbands are the only ones entering, and that no alcohol is leaving that area. City Attorney Shaver asked anticipated attendance and Ms. Gerber guessed 150 – 200 people with half of those people drinking. Hours of the event are noon – 7:00 p.m. and Ms. Gerber ensured that those secure procedures will be adhered to consistently throughout the entire timeframe. City Attorney Shaver asked for clarification of the event. Ms. Gerber explained that this is a rafting trip that begins at Corn Lake and ends at Las Colonias Park which is where the beer garden will be provided.

City Attorney Shaver asked Ms. Gerber to verify the signature on the application and upon her verifying it was hers, asked her if she verified the information to be true and accurate and she said it was.

No one was present that opposed the application.

Hearing Officer Starritt admitted Exhibits A and B into the record (attached) and found that pursuant to Colorado Revised Statutes 12-48-106, there are no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event, its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. The application for special events permit submitted by the Rotary Club for the 2017 Rock and Raft Beer Garden was approved.

Event Manager Miranda Wertz was present.

City Attorney Shaver noted four documents, two marked Exhibit A, one marked Exhibit B, and one Exhibit C. City Attorney Shaver asked if Wertz was familiar with these documents and she said that she was, that she had completed them. City Attorney Shaver verified that this fundraiser was in its sixth year and asked Ms. Wertz if there had been any issues in the past to which she answered no. City Attorney Shaver then asked Ms. Wertz to describe how the alcohol service will be conducted and how lawful service will be ensured. She responded that they will have trained servers who check ID's at the entrance and provide wristbands to those people 21 years of age and older. There will also be security walking around the venue ensuring that people are drinking lawfully. Ms. Wertz anticipates 400 participants which is slightly down from past events, but security will remain the same, which in the past, has been sufficient.

City Attorney Shaver asked Ms. Wertz to describe the venue on Exhibit B and C, the event diagrams. Ms. Wertz explained that the event will be in a fenced area with a snow fence surrounding the event as well as the drinking area. Security guards will be posted at the entrance/exit checking wristbands outside of the entrance/exit to make sure people with wristbands are the only ones entering, and no one is exiting unless they are leaving for good. She explained that exhibit C is within the area of fencing in exhibit B. Hours of the event are 10:00 a.m. – close.

City Attorney Shaver asked Ms. Wertz to verify the signature on the application and upon her verifying it was hers, asked her if she verified the information to be true and accurate and she said it was.

No one was present that opposed the application.

Hearing Officer Starritt admitted Exhibits A, B and C into the record (attached) and found that pursuant to Colorado Revised Statutes 12-48-106, there are no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event, its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. The application for special events permit submitted by March of Dimes for MUDD Volleyball was approved.

We will have a minimum of 4 volunteer security staff throughout the area to ensure no beer leaves the secured area. These volunteers will wear like clothing (vests) to identify them as security. 7. What is the Control Plan for security at this event? (Use additional sheet if necessary) Please see the map included with this application. The area will be fenced and include only one entrance/ exit. No beer will be allowed to leave the secure (fenced) area. Two volunteer security staff will monitor the entrance/exit at all times. Two additional security volunteers (for a total of 4) will monitor the perimeter fencing to ensure no alcohol leaves the secure/fenced area during the event. Other volunteers will check valid identification and those who are 21 or older will be issued a tamper resistant wrist band. Only those adults wearing the event-issued wrist band will be served beer.
8. How will security personnel be identified? The will wear shirts with the word "security" on them or matching neon vests.
9. If this event is being held outdoors, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?
Temporary fencing will be used to secure the are where beer will be served/consumed. Signs will be used
to convey that no alchol is allowed outside of the secure/fenced area and that adults must be 21 years or older to purchase beer.
