

JAM Hospitality, LLC filed an application with the Local Licensing Authority on December 15, 2017 for a new hotel and restaurant liquor license permitting sales of malt, vinous, and spirituous liquors by the drink for consumption on the premises at 417 Monument Road, Unit 1, under the trade name of HandleBar. The application and supplementary documents were reviewed, found to be in order and accepted. A copy was sent to the State Liquor Enforcement Division for a Concurrent Review. The hearing date was set for January 17, 2018. The Notice of Hearing will be given by posting a sign on the property on or before noon on January 3, 2018 and by publishing a display ad in the Daily Sentinel on January 12, 2018.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded on the North by Gunnison Avenue, South by D Road, 1st Street on the East, and Country Club Road on the West and includes both sides of the streets as the outer boundaries. The results of that survey are as follows:

There were four exhibit sheets that indicated 4 responses that refused to sign, 1 that was not 21 YOA, 18 no answer, 4 refused to sign, 12 had no solicitors, and 1 other.

No letters of opposition or counterpetitions have been filed to date.

The Grand Junction Police Department will be investigating the owner and operating manager for local criminal history and verifying that the Notice of Hearing was posted in a timely manner and that the diagram matches the establishment. The fingerprints were forwarded to CBI for further processing. Reports have been requested by the Grand Junction Fire Department, the Grand Junction Sales Tax Department, and Mesa County Health Department.

Hotel and Restaurant = 5 (Two Rivers Convention Center, Fly'n Roosters, Warehouse 2565, Doe Hombres, and Aztecas)
 Tavern = 1 (Charlie Dwellington's)
 Retail Liquor Store = 2 (Redlands Liquor Store, GC Discount Liquor)
 3.2% Beer (Off Premises) = 3 (Safeway, Alta #6312, and City Market #32)
