Describe the event: The Children of the Music Sparks orchestra began music rehearsals in September, learning how to hold the instrument, bowing, music reading and compositions to perform. On Tuesday evening, December 12, 2017, all of the

ensembles did a combined concert at Riverside Elementary/ Duel Immersion Academy

What were the strengths of the event?

Students who normally aren't involved with outside organization have the opportunity to be in a structed organization. Students range from Kindergarten to 5th grade. These students have an excellent opportunity to learn about music and play a string instrument. They learn to be dependable, responsibility, team player, hand and eye movement and reading and listening skills.

What were the weaknesses of the event?

The only weakness was not having the music arranged in a timely manner for outside wind players to join and support the music event. There were only 4 musician who attended the evening rehearsal.

What suggestions do you have to improve this event?

If outside players are going to perform, have the music ready for them 6 weeks prior to the performance.

Participants: 33 children, ages 5 to 10

This event was a concert for supporters and family of youngsters who have been involved in the MusicSpark music program, which emphasizes learning of music by violin. It is currently focused on atrisk youth, often of immigrant parents, and who do not often have an opportunity to experience such things as orchestral music.

Strengths:

Strong Community and Parental support

Excellent teaching volunteers: Gisela and Sean Flanigan, Allison Kitto

Perfect choice of Guest Conductor, Mr. Gary Ambrosier

Kids have learned good form and bow position, some excellent. High degree of discipline. Music reading has been learned. All children VERY engaged with program. Good Concert etiquette. By showing different age classes and experiences, able to track progress as these children become more proficient. VERY strong family support evidenced. Spoke to several parents, uncles, grandparents, all very proud of their children's musical accomplishment, and the ways the children react to the program.

Weaknesses:

Needs to be expanded to include more of these children, and I believe there is not enough instruments or teachers to do so. It would good to see if there is any way for children to take instruments home with them for practice.

No suggestions for improvement at this time. GJCAC funds well spent! The program clearly acknowledged the GJCAC grant, and it was also announced to the guests at the concert. I also noticed this group has garnered some significant community support from donors and other non profits, such as service clubs, and seems well organized.

Describe the event:

Riverside hires seven local artists to provide high quality, small group classes to fifty K-8th grade students one night a week for fourteen weeks during the fall semester. The art activities culminate in our "Look What I Did" event which allows students to showcase their artwork in an art walk and also to perform on stage in a variety of mediums for friends, family, and the community.

What were the strengths of the event?

There was a lot of love and a lot of pride in that room. Attendees were mostly, as to be expected, family of students. There was applause, cheering and appreciation after every performance. The students were encouraging to one another. They exhibited confidence. The instructors led the students but it was student-driven. I really enjoyed the drumming performance. Students took turns describing the rhythm they would perform, where it came from, its significance, etc. It was about culture as much as it was about the music. They also had a staff member translate everything in Spanish, which always received a strong response, and it was clear that these families appreciate Riverside, their staff, and everything they do for their kids.

What were the weaknesses of the event?

The event is also a potluck dinner, which is an understandable draw and no doubt intended to encourage socialization, but it seemed to be "about" the food, which was a little distracting. It doesn't seem intended for outside community members to attend. I had to ask a few times if I was headed towards the right place. The Commission's logo was not on the event's poster, nor was the Commission mentioned at any time during the evening.

What suggestions do you have to improve this event?

A student art show is bound to attract their parents, families and maybe not many outside of that, but that seems perfectly fine. It's an event to celebrate the kids' accomplishments, and it was terrific at doing that. If food will remain an emphasis, it would be cool if kids had a hand in that, too. (Maybe "culinary arts" is a part of the program?) I feel as if the artists/instructors were not introduced, and that would have been nice to include. I also would like to have heard the Commission's support mentioned.
