Throughout the event the uniform security officer and trained servers will monitor intoxication and conduct. These staff members are TIPs or safe server trained. Service of alcohol is paired with dinner.

8. How will security personnel be identified?
The security officer will be in uniform, provided by Citadel Security.

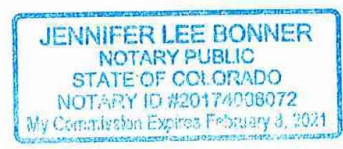

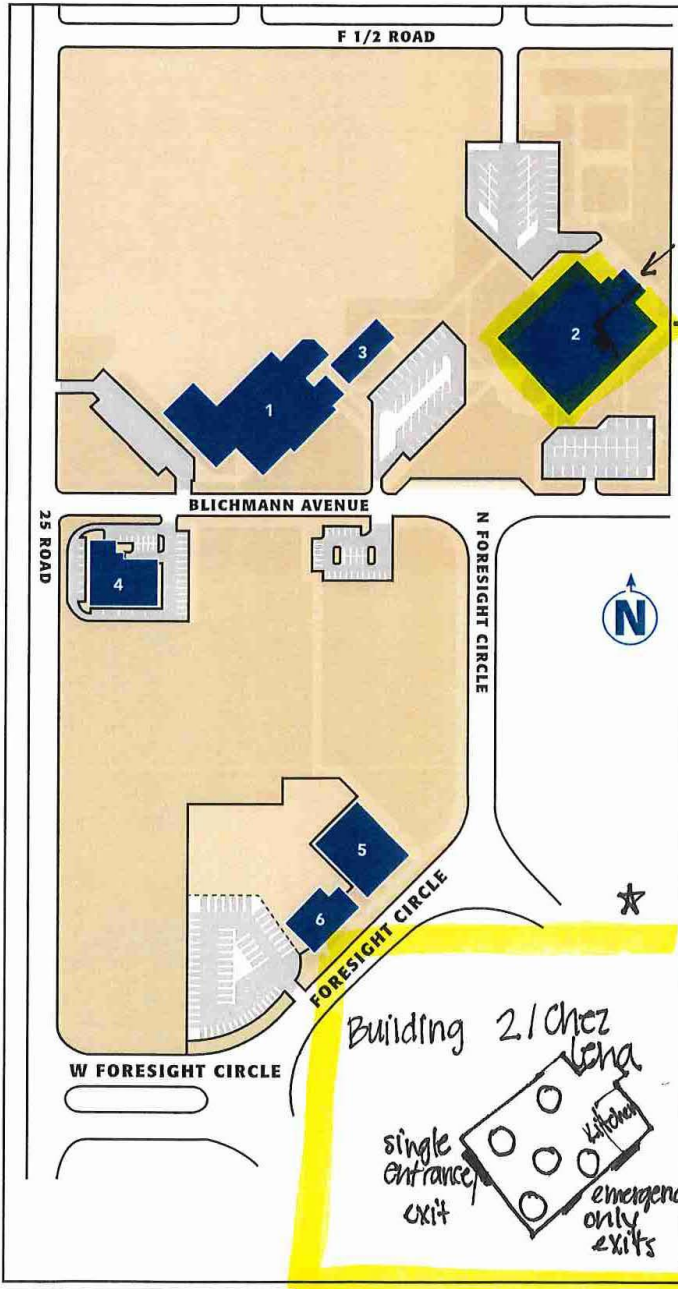

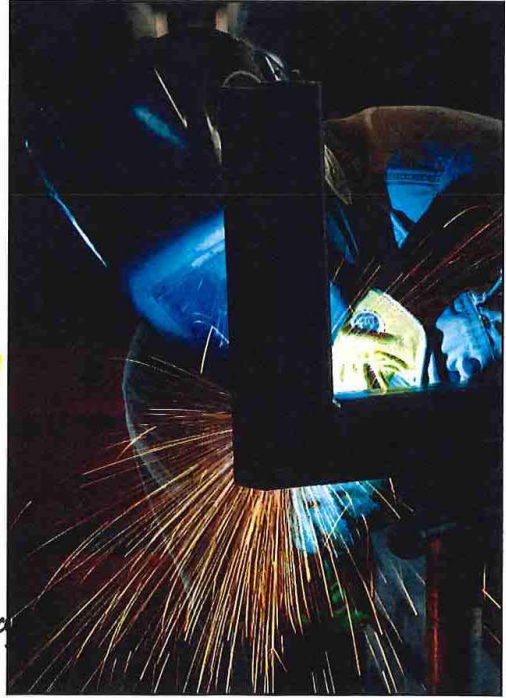
BISHOP CAMPUS

There will be 2 hired Citadel Security guards in uniform. Additionally there will be 5 CMU staff/volunteer identifiable in CMU volunteer shirts.

7. What is the Control Plan for security at this event? (Use additional sheet if necessary)
The event will be held inside a fenced area with only one entrance/exit for attendees. Only those 21+ will be allowed to enter the beer garden area. Everyone 21+ will be wristbanded upon entry. A hired Citadel security guard will be responsible for verifying that everyone is 21+ at the entrance. Once security guard will be positioned here for the whole event to ensure no alcohol enters or leaves the area. The other three Citadel personel will be canvassing the premise to monitor intoxication and conduct. They will also monitor the interior barriers to be sure no alcohol is passed over those fences. Beer will be served by TIPs trained staff and trained CMU volunteers. The trained servers will also monitor intoxication and conduct. Cont...

8. How will security personnel be identified?
Citadel personnel will be in uniform. Other CMU staff and volunteers will be in CMU volunteer t-shirts.

9. If this event is being held outdoors, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?
The event will be held outside, please see attached map for details. All beer garden boundaries will be fenced. Outer perimeter will be fenced using 6ft security fencing. The interior boundaries are fenced with ped fencing. There will only be one entrance and exit point. All interior boundaries are double fenced.

Should the trained servers question the age of anyone at the service area they will ask to check their ID again. The servers will not serve anyone who is not wearing a wristband. They will instruct them to see the Citadel officer to have their age verified and get a wristband.

ID will be checked at the door for all attendees. Underage patrons will not be allowed into the beer garden. Trained servers will only serve someone wearing a wristband. If a server questions the age of an attendee they may again as to verify their age at the bar. Anyone without a wristband will be sent back to security.

Conduct and intoxication will be monitored by the 3 canvassing security guards as well as the trained CMU staff and volunteers who will be serving alcohol and providing additional security at the event.

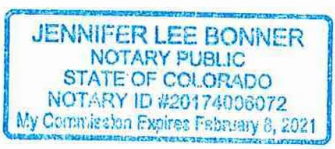

The events take place on the front lawn area of the Western Colorado Botanical Gardens, south of Struther Ave and at the south end of 7th street.

6. What type of and how many security will be provided at this event and how will they be identified?
We use 2 paid security personnel from CSI security. We have two to three volunteer security personnel which are identified by wearing yellow vests with the word security in bold black letters on the backs.

7. What is the Control Plan for security at this event? (Use additional sheet if necessary)
We position one paid security person at the gate (the only entrance and exit) of the event from start to finish. The additional paid security person is positioned in the area where the alcohol is served and tickets are purchased. The three volunteer security personnel are positioned at the following locations: 1.) ID check and banding area 2.) behind the stage area 3.) front stage area. All possible issues observed will be brought to my attention and dealt with accordingly with the paid security staff and myself.

8. How will security personnel be identified?
The paid security staff will be dressed in the CSI uniform and the volunteer staff will wear a yellow vest with the word security in bold black letters security on the back.

9. If this event is being held outdoors, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?
There is a permanent six foot high steal fence surrounding the entire area of the gardens. There is only one entrance and exit during the event, which is located at the east end of the garden area.
