Describe the event: The free concert series was held across the valley at various city parks. Band members played songs from movies and musicals. For example: James Bond and Disney. I attended the Spring Valley II concert. I was impressed that band members varied in age from children/teens to seniors. I thought it was neat how some neighbors stepped out of their doors or hung out in their yards to hear the music. The crowd was mostly adult, with some small children and families. It was delightful, good ol' family fun.

What were the strengths of the event? The music seemed to have broad appeal and made you want to sing along. You could tell attendees enjoyed it. It felt like an intimate, neighborhood event. The conductor was very animated and thanked the Arts & Culture Commission several times. I also thought the amount of promotion on Facebook was good with attractive graphics.

What were the weaknesses of the event? The sound didn't carry as much as I expected. I'm not sure if it was the park's acoustics or what.

What suggestions do you have to improve this event? The event itself was very pleasant, but I would have liked to see more of my neighbors there. Sharing with specific neighborhoods by way of HOAs or neighborhood websites (Nextdoor) might help. Perhaps sending targeted postcards would be a good way to spread the word.

Describe the event: This event relates history through performances by actors/historians of historical figures. The theme this year was WWI. Most of the content was single performers telling of a specific time in the life of the person they were portraying. The event is performed in many venues including The Avalon Theater and the Main Branch of the Public Library. The performers include a younger group along with adults.

What were the strengths of the event: It was engaging and informative. While many of the people depicted were unfamiliar to me their roles in history and the interactions they had with well known figures were presented in an entertaining and informative way. It was well organized and executed. The museum spent a good deal of time and resources reaching out in their marketing to the community.

What were the weaknesses of the event: Like many of the performing arts events in our Valley the demographic was heavily weighted towards an older crowd. It would be good to see a wider audience. Even though the museum was happy with the attendance, I felt there could have been a larger audience. It will take people really talking about how great the event is for it to grow.

What suggestions do you have to improve this event: Perhaps more outreach to a wider demographic, CMU and D51 for example. Continue to broadcast a wide variety of marketing, utilize downtown resources to help get the word out.


Week 10, STEAM: Discover why educators include art in STEAM. Projects will include magnetic paint, gravity, tiny energy dancer sculptures, and life-cycle flip books. Plus what's in outer space—bottle rockets, paint the planets, and design your own space outfit. (from website)

STEAM: Science, Technology, Engineering, Arts and Mathematics

From Printmaking, to Film, Theater, clay techniques, magnetic painting, music, hot air balloons, the young artists and their instructors are creating much more than traditional art this summer. They are incorporating the 5 areas of "STEAM" into their works. STEAM stands for Science, Technology, Engineering, Arts and Mathematics. It is a movement championed by the Rhode Island School of Design and widely adopted by institutions, corporations and individuals by encouraging integration of Art + Design in K-20 education. As Vera Mulder, one of the teachers described the "A" for Arts&Design as being the center from which the others emanate. The Art Center's teachers are incorporating STEAM into all of their classes. Art + Design teaches young children how to Think-Outside-of-the-Box and should begin at the K in K-20.


STEAM stimulates and develops the imagination and critical thinking, and refines cognitive and creative skills.

- Has a tremendous impact on the developmental growth of every child and has proven to help level the "learning field" across socio-economic boundaries.
- Strengthens problem-solving and critical-thinking skills, adding to overall academic achievement and school success.
- Develops a sense of craftsmanship, quality task performance, and goal-setting-skills needed to succeed in the classroom and beyond.
- Teaches children life skills such as developing an informed perception; articulating a vision; learning to solve problems and make decisions; building self-confidence and self-discipline; developing the ability to imagine what might be; and accepting responsibility to complete tasks from start to finish.
- Nurtures important values, including team-building skills; respecting alternative viewpoints; and appreciating and being aware of different cultures and traditions.
- influence employers to hire artists and designers to drive innovation




Nora Hughes teaches
