ORDINANCE NO. 924

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION

(MESA GARDENS)
Western States Cons

WHEREAS, a Petition to annex the property hereinafter described to the City of Grand Junction, Colorado, was filed with the City Clerk and considered by the City Council on June 1, 1955; and

WHEREAS, the said City Council at that time found the said territory to be eligible for annexation, the Petition to be signed by the required number of landowners, and all other requirements of Section 2 of Chapter 314, Session Laws of Colorado, 1947, to be satisfactorily complied with; and

WHEREAS, the City Council did accept and arprove the said Petition for annexation by its Resolution dated June 1, 1955; and

WHEREAS, Notice of the filing of said Petition has been published once each week for four publications in the Daily Sentinel, the first publication being on June 6, 1955, and the last publication being on June 27, 1955; and

WHEREAS, thirty days have elapsed after the first publication of said Notice and no Counter-Petition or written objection to the said annexation has been filed with the City Clerk of the City of Grand Junction;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

That the said annexation is approved and that the following described property shall be and it is hereby declared to be annexed to the City of Grand Junction, Colorado:

The SE $\frac{1}{4}$ NE $\frac{1}{4}$, E $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ and E $\frac{1}{2}$ W $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 13, Township 1 South, Range 1 West of the Ute Meridian, Mesa County, Colorado, known as Mesa Gardens Subdivision except Lot 24 of Block 11 and except all of Block 12 of said Mesa Gardens.
