Sidewalk Cleaning

Plan of Development

The first meeting with the Community Task Force was held on October 26th. There were 25 attendees. Some of the talking points were connectivity to Downtown, transportations issues, housing, vacant land,

economic development issues, wayfinding, safety and comfort. The next event is scheduled on Thursday, November 15th, from 4:30 pm to 6:00 pm at The Rockslide Brewery and Restaurant.
