

ALLEN DISPLAYS, INC. SHALL MANUFACTURE FO.D. GREENSBORD, NC, SIGN UNITS AS SHOWN. SIGN ILLUSTRATED IS SIZED & 65.33 SQUARE FOOT AREA. CABINET DIMENSIONS SHALL BE 6.083" x 8.083" x 12".

SIGN CABINETS ARE CONSTRUCTED FROM ALLEN 10.3" ALLIMINUM FRAMING EXTRUSION WITH MATCHING 2" FACE RETENTION EXTRUSIONS, ONE SIDE SHALL FEATURE HINGED RETENTION FOR SERVICE ACCESS. CABINETS ARE INTERNALLY ILLUMINATED UTILIZING HIGH OUTPUT FLUORESCENT LAMPS POWERED OFF BOOMA BALLASTS, NOTE SERVICE ACCESS SWITCH ON CABINET RETURN (ABOVE).
