

Dear Bud:

On September 19, 1994 the City Council passed a resolution amending various permit fees including sign permit fees. Sign permit fees are now \$25.00 for the first sign and \$5.00 per additional sign on the same property for which a permit is obtained at the same time. Council also approved a \$100.00 penalty for failure to obtain a permit prior to erecting a sign. Although a permit has always been required <u>prior</u> to putting up a sign, the automatic \$100.00 penalty is new. Therefore, we are allowing one written warning for each sign company prior to assessing the \$100.00 penalty. This letter will serve as the one warning to Bud's Signs for putting up the sign at 1036 N. 4th Street, Sylvan Center, without a permit. The \$100.00 penalty will be assessed for any future signs put up without a permit.
