A formal issuance of a sign permit requires the permit fee to be paid and the permit to be picked up by the sign contractor before any signs can be installed or worked on. The installation of signs without an approved permit will result in a penalty of \$100 in addition to the sign permit fee. Our staff has been instructed to collect this penalty if the proper procedure is not followed. This is your one and only official warning notice.
