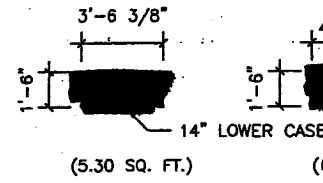

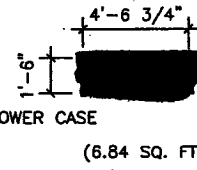
① SPACING DIMENSIONS N.T.S.
(50.47 SQ. FT.)



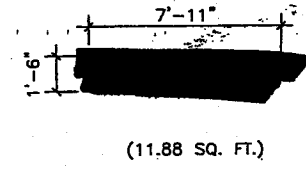
② SPACING DIMENSIONS N.T.S.

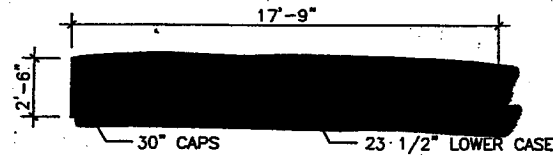

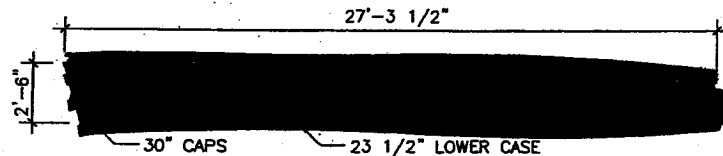

② SPACING DIMENSIONS N.T.S. PATTERNS PROVIDED

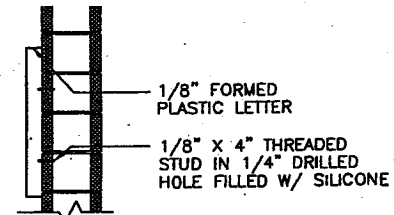


③ SPACING DIMENSIONS N.T.S.

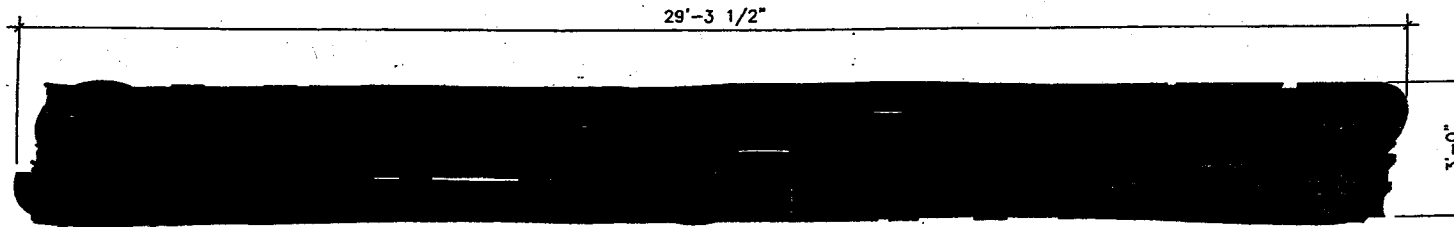
