Service Agreement

BETWEEN: City of Grand Junction, Grand Junction Police Department, 625 Ute Avenue, Grand Junction, CO 81501

AND

DOCVIEW, LLC, 113 Pere Marquette, Suite C, Lansing, MI 48912

IN CONSIDERATION OF THE COVENANTS and agreements contained in this Service Agreement, the parties to this Agreement agree as follows:

Responsibilities and Compensation for each Party

- 1. The LEA will accept the sum of \$ 0.25 for each report downloaded by an insurance company within 45 days of the actual download. A \$ 0.25 compensation will be provided to the LEA for any report that is downloaded by a citizen or other entity (including insurance adjusters, law firms, road commissions, or other government agencies where fees are assessed).
- 2. Compensation will be provided monthly to the LEA from DOCVIEW, LLC via check made payable to the City of Grand Junction, and mailed to the address shown above.
- 3. All agencies participating in the TRACView service have free access to the reports that are scanned to the TRACView system.
- 4. The LEA will electronically send all traffic accident reports completed by their agency to the TRACView system within 24 hours of completion. This does not include weekends or holidays as defined by the LEA.
- 5. The LEA will direct <u>all</u> insurance companies and other entity requests for traffic accident reports to the TRACView system within 30 days of implementation of TRACView. LEA will return all requests received by mail to the requesting entity within 45 days or sooner of implementation.
- 6. The LEA understands that any insurance agency, LEA or other entity deemed appropriate by the LEA and DOCVIEW, LLC may access the traffic accident images. The LEA authorized agent acknowledges this by his signature.

Excuse for Delay or Failure to Perform

7. The DOCVIEW, LLC or the LEA will not be liable to one another in any way for a delay, non-delivery or default due to labor disputes, transportation shortage, delays in receipt of material, priorities, fires, accidents and other causes beyond the control of the DOCVIEW, LLC or the LEA.

Cancellation

8. DOCVIEW, LLC and the LEA reserve the right to cancel this Agreement. Notice of cancellation in writing to the LEA, or to DOCVIEW, LLC shall be made 30 day prior to the cancellation becoming effective. This agreement may be extended for succeeding one year periods with mutual agreement of the parties.

Notices

9. Any notice to be given or document to be delivered to either DOCVIEW, LLC or the LEA pursuant to this Agreement will be sufficient if delivered personally or sent by prepaid registered mail to the address specified above.
