

ORDINANCE NO. 1248

AN ORDINANCE APPROPRIATING CERTAIN SUMS OF MONEY TO DEFRAY THE NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION, COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 1967, AND ENDING DECEMBER 31, 1967 AND FIXING THE SALARY OF THE CITY MANAGER OF SAID CITY AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

Section 1. That the following sums of money, or so much thereof as may be necessary, be and the same are hereby appropriated for the purpose of defraying the necessary expenses and liabilities of the City of Grand Junction, Colorado, for the fiscal year beginning January 1, 1967 and ending December 31, 1967, said sums to be derived from the various revenue funds as indicated:

Section 3. That commencing January 1, 1967, the salary of the City Manager of the City of Grand Junction, Colorado, shall be twelve thousand dollars (\$12,000) per annum.

Section 4. It is hereby declared that a special emergency exists and that this ordinance is necessary for the preservation of the public peace, health and safety and shall take effect upon its passage.
