

ORDINANCE NO. 1256

AN ORDINANCE AMENDING SECTIONS 3-b (12) A AND 3-b (13) A OF CHAPTER 32 OF THE CODE OF ORDINANCES OF THE CITY OF GRAND JUNCTION TO PERMIT MEMBERSHIP CLUBS IN INDUSTRIAL DISTRICTS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

Section 1. That Section 3-b (12) A of the Code of Ordinances of the City of Grand Junction be amended to read as follows:

Section 2. That Section 3-b (13) A of the Code of Ordinances of the City of Grand Junction be amended to read as follows:

b. Zone Districts

(13) I-2 Heavy Industry

A. Permitted Uses:

Assembly Use . . . 2.1, 2.3, 2.5, 2.6

Institutional Use . 3.1, 3.5

Business Use . . . 4.1, 4.2, 4.3, 4.5, 4.6, 4.7, 4.8

Commercial Use . . 5.1, 5.2, 5.3, 5.4, 5.5, 5.6, 5.7, 5.8, 5.9, 5.10

Industrial Use . . . 6.1, 6.2, 6.3, 6.4, 6.5
