always known. However, we still have plenty of work to do to make sure it remains a great place for those who already live here.

In 2019, as we continue to work for all of you alongside our very committed City staff to implement the directives of our strategic plan, we have several important things before us. In April 2019 voters will elect citizens to City Council representing Districts B and C and one District at Large. You will also vote to let us know if a new tax for a community center is something with which you agree. We will be moving forward with one of our many partnerships to greatly expand the potential for our local convention center and spur even more vibrancy downtown. We will be opening a temporary ambulance station on 27 Road in anticipation of a permanent fire station. And we will be reaching out to all of you as we begin the review of our Comprehensive Plan which will continue to help guide us as we manage and direct the growth and livability of Grand Junction.

On behalf of your City Council, we wish each of you a tremendous 2019 and thank you immensely for making Grand Junction the wonderful place it is!

This is Just Some of What Kept Us Busy in 2018:

- The City and Mesa County partnered on a future proposed 29 Road/I-70 interchange by signing a Memorandum of Understanding (MOU) for a preliminary environmental study.
- Under a contract with a private management company, Two Rivers Convention Center and the Avalon Theatre had one of the best years ever resulting in a \$195,000 decrease in City subsidy.
- · Robust development activity related to a strengthening economy kept our Community Development Department extremely busy.
- Partnering with Colorado Mesa University, the City allocated \$250,000 to the "Grand Junction Opportunity Scholarship Program" which funded college scholarships for 2018 graduates of District 51 schools.
- · We broke ground on Las Colonias Business Park, which along with Las Colonias Park, will restore and revitalize over 147 acres of City-owned land along the Colorado River into a vibrant recreational and business environment.
- · We congratulated new Mayor Barbara Traylor Smith and returning Mayor Pro Tem Bennett Boeschenstein.
- · Results of a Community Center feasibility study were presented to City Council demonstrating

- the community's support. Council responded by forwarding a ballot question to the April election on the matter.
- · Reconstruction of 7th Street between North Avenue and Orchard Avenue was completed and the second phase from Orchard Avenue to Patterson will roll out in 2019. These projects, along with many others around town, are being paid for with funds approved by voters in the April 2017 election.
- A \$7.3 million renovation of Two Rivers Convention Center was awarded in preparation for construction of a hotel to be constructed by local business owners. Once complete, the hotel will be connected to the convention center and provide a significant increase in available conference space and spur additional commercial activity downtown.
- A house on 27 Road just north of G Road was purchased to construct a temporary ambulance station. The property will become the home of permanent Fire Station #6.
- · Due to prolonged drought and high temperatures, mandatory water restrictions were implemented for all City of Grand Junction water customers who use City water for outdoor use. City facilities, including parks and golf courses, followed suit.
- · Improvements to pedestrian safety along Horizon Drive were advanced with the installation of three crosswalks and new lighting between G Road and I-70.

All board members are appointed by the Grand Junction City Council and serve without compensation. Boards and commissions are established for the purpose of acquiring and studying information in specific areas and to make recommendations to City Council on issues within the board's area of expertise.

Recruitment efforts are made throughout the year, with vacancies advertised on the City's website. City Council reviews the applications and determines whether an interview session is appropriate. The City Clerk's Office coordinates the recruitment and appointment process for all boards and commissions.

Each board and commission is supported by a staff liaison and a Council liaison.







The following charts, unless otherwise stated, are based on the 2018 City of Grand Junction budget as adopted by City Council in December 2017.

City Revenue Sources








How the Revenues are Spent by Department



How the Revenues are Spent by Category








NOTE: Gasoline, groceries, and prescription medicine are exempt from sales tax.
