Topic: North Avenue Zoning Overlay District and Planning Update

### Summary:

As part of the City's efforts to help revitalize North Avenue business and streetscape, the City Council appointed an advisory committee earlier this year. Also over the past few months a North Avenue business group has organized on its own to look at ways to revitalize the corridor. At this readiness session Council will be briefed on this planning work. Staff is seeking City Council's input on what has been accomplished to date and future direction.

### **Background, Analysis and Options:**

The North Avenue Advisory Committee has been meeting monthly since February to work on a Zoning Overlay district for North Avenue and learn about various funding tools that are available that can help implement the vision of the corridor as defined by the community and established in the North Avenue Corridor Plans competed in 2007 and 2011.

The vision of the North Avenue corridor as developed by the 2007 and 2011 North Avenue Corridor Plans is to create a corridor with a sense of place ("Placemaking") that people want to come back to and not just pass through. It is a corridor that provides a vibrant mix of uses including, retail, office, residential, medical, employment centers and supportive of a university, public spaces and sports facilities.

At this workshop several people will present to City Council the progress made to date on planning North Avenue. In addition to staff, a representative from the North Avenue Advisory Committee, a representative from the North Avenue business group and City Council representative Sam Susuras will brief Council. Topics that will be presented include the following.

- North Avenue today existing conditions and examples from other city's
- The vision of the corridor and overlay zoning
- The work of the North Avenue Advisory Committee
- The work of the Technical Advisory Committee
- The work of the North Avenue business group
- The draft Zoning Overlay District for North Avenue

**Topic:** Greater Downtown Plan Update

**Summary:** City Council gave Staff direction at its September 19, 2011 workshop to move forward with a planning process for a Greater Downtown Plan. Since then, Staff has been working on development of the Plan, including technical committee meetings, meetings with individual property owners, community groups and two public open houses.

### **Recent Actions:**

1) In conjunction with the Chamber of Commerce, a meeting was held on June 28, 2012 to discuss the proposed corridor overlay zoning.

- All owners of properties potentially impacted by the overlay were invited.
- Approximately 35 persons attended
- Staff presented a detailed explanation of the goals of the overlay, details of the proposed design standards and guidelines and provided examples of how it will be implemented as development/redevelopment occurs in the Greater Downtown corridor areas.
- The proposed Future Land Use and Zoning Maps were also available for review and staff discussed questions and concerns with individual property owners.
