BE IT KNOWN THAT:



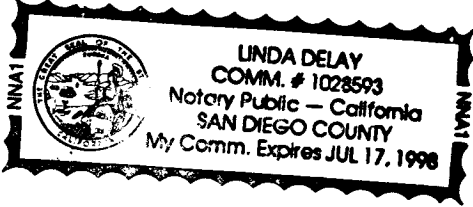
