BE IT KNOWN THAT:
I, (WE), Hope Haven, Man Shaw and PoB as owner(s) of the real property described above, located in the City of Grand Junction Colorado, agree that, as a condition of City approval of development of the property, the alley(s) which adjoin(s) the above described property is (are) required to be improved or reconstructed to City standards and specifications.
