BE IT KNOWN THAT: A Decchas owner(s) of the real property) Smu tonse I, (WE), described above, located in the City of Grand Janction Colorado, agree that, as a condition of City approval of development of the property, the alley(s) which adjoin(s) the above described property is (are) required to be improved or reconstructed to City standards and specifications. The required improvement or reconstruction has, with the consent of the City Manager, been deferred to such time, if any, as an alley improvement district, or equivalent legal mechanism, is formed for that certain alley described above. The estimated cost to the owners, or their heirs, successors and assigns, in 199 dollars is SUNCY. The actual cost which I will pay will be determined in accordance with rates and policies established by the City at the time of formation of the improvement district.
