MEMORANDUM OF AGREEMENT

This Memorandum of Agreement entered into this <u>13</u> day of September, 1979, by and between WESLEY HARRIS WILLIAMS and FLORENCE M. WILLIAMS, hereinafter "Williams", and the CITY OF GRAND JUNCTION, hereinafter "City";

RECITALS

Williams are the owners of the property situate in the City of Grand Junction, Mesa County, Colorado, described as:

> Lot 1 and the North 12 feet of Lot 2 in Block 4 of Meeks Subdivision, Section 18, Township 1 South, Range 1 East of the Ute Meridian.

The City is proposing to put in a storm sewer within the area of the property and can install the sewer along the front of the property of the Williams.

The City also plans for future improvement of the street abutting the property of the Williams;

NOW, THEREFORE, IN CONSIDERATION OF THE COVENANTS HERE-INAFTER SET OUT, IT IS AGREED:

1. The City will extend the proposed storm sewer from Hill Avenue along the property of the Williams to the south line of that property. The Williams will pay two thirds (2/3) of the cost of such extension at such time as they are billed for the same.

2. The Williams agree that at such time as the City determines to improve 28 1/2 Road in front of their property, the City Clerk of the City of Grand Junction shall have the authority to sign any petition for the same, if one is needed, on behalf of the Williams or their successors in interest committing the assessment of the property to the cost of such improvements, including curb, gutter and sidewalk and paving, in accordance with the then method of assessment for such improvements. To this extent, the Agreement shall run with the land and be binding upon those successors in interest.
