- I. **CALL TO ORDER**- The meeting convened at 2:00 p.m. Those present were Hearing Officer Michael Grattan, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson

- II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**
 1. Walmart Stores Inc., dba Walmart Store #5099, 2545 Rimrock Avenue, Grand Junction, CO 81506, 3.2% Beer Retail (Off-Premises)

No one was present representing the applicant.

The application for renewal for Walmart Stores Inc., dba Walmart Store #5099 was found to be in order and approved.

 2. Texas Roadhouse of Grand Junction, LLC dba Texas Roadhouse, 2870 North Avenue, Grand Junction, CO 81501, Hotel and Restaurant

IV. APPLICATION TO RENEW LIQUOR AND BEER LICENSE WITH LATE FILING

1. Manuel Alvarez dba Taqueria Valparaiso, 511 30 Road, Grand Junction, CO, 81504, Hotel and Restaurant – Filing 12 days late

Maria Alvarez, daughter of the owner along with Manuel Alvarez was present. Ms. Alvarez said the reason for the late filing was due to the restaurant being robbed for a second time.

Hearing Officer Grattan asked Ms. Alvarez if she had the police report to submit. She said no, but that delayed them filing and her dad thought he only had to submit 30 days prior to expiration.

Ms. Peterson reported that all the reports are in compliance. Hearing Officer Grattan explained to Ms. Alvarez that he has seen her about 5 times this year and hopes they can get organized and only be back for their renewal next year.

City Attorney Shaver concurred with Hearing Officer Grattan and said he believes there to be good cause for the late filing since this is their first renewal. The application for renewal for Manuel Alvarez dba Taqueria Valparaiso was approved.

There was no one present representing the applicant. Ms. Peterson said the application is in compliance along with sales tax.

The application for renewal for Frame Depot Inc. dba Frame Depot was found to be in order and approved.

Ms. Connie Howard, General Manager, was present. Ms. Peterson reported the paperwork was submitted in a timely manner and C.B.I./F.B.I. is still pending, but the local background check is in compliance. No other reports were required as the new license was just approved and reports were less than 3 months old.

Hearing Officer Grattan approved Ms. Howard as the registered manager pending a clear report from C.B.I./F.B.I.

Mr. Phillip Carter, Chaplin, was present to represent the Elks.

Ms. Peterson reported the paperwork was in order. City Attorney Shaver asked Mr. Carter to look at Exhibit A (see attached) which he marked and described the area. Mr. Carter said this was the main floor of the Elks Lodge and where the event will be. City Attorney Shaver marked the Special Event Permit Questionnaire and Affidavit Exhibit B (see attached) and asked Mr. Carter if he was familiar with this document. He answered affirmatively. City Attorney Shaver asked about question 5 in regards to the 3-4 officers, if this was Police Officers or Lodge Officers. Mr. Carter said Lodge Officers will be conducting the security.

Hearing Officer Grattan asked Mr. Carter to describe the event. Mr. Carter said that this event will start at the Lodge with donuts and coffee and there will be 5 total stops on the poker run. The event will end up back at the Lodge and then this is when the alcohol will be served.

Hearing Officer Grattan asked City Attorney Shaver is he had anything else. City Attorney Shaver said he just recommends approval. The application for a Special Events Permit for the 1st Annual Poker Run for August 19, 2012 was approved.

VIII. APPLICATION FOR TRANSFER OF OWNERSHIP

Mr. Andrew Pittman, Member, was present. Ms. Peterson said the applicant has a temporary license and all the paperwork is in order. The Police and Sales Tax reports are in compliance. The Fire Department needs to do their inspection and Mesa County Health Department said they have been contacted by Mr. Pittman to add sandwiches to his menu.

Hearing Officer Grattan asked Mr. Pittman if he was a Managing Member. Mr. Pittman said no, just a member.

Ms. Peterson said at the August 15, 2012 meeting Mr. Pittman will be back with an application for a modification to add an outdoor dining lease that is before the City Council this evening.

Hearing Officer Grattan asked City Attorney Shaver if he had anything else. City Attorney Shaver said he recommends approval.

Hearing Officer Grattan asked if there was anyone present in support or objection to this license being transferred. Seeing no one, the application to transfer the Tavern Liquor License to Mesa Theater and Lounge LLC dba Mesa Theater and Lounge is approved contingent on the Fire and Health Department reports being in compliance.

IX. APPLICATION FOR NEW LICENSE – RESOLUTION AND FINDINGS AND DECISION

Mr. David Weaver, President along with Lizann Sinclair, Operating Manager were both present.

Ms. Peterson reported the paperwork is in order and the applicant has a hotel and restaurant license they will surrender upon approval of granting this tavern license. All the reports are in compliance. Ms. Peterson read the results of the needs and desires survey into the record (see attached).

City Attorney Shaver asked who conducted the survey. Ms. Sinclair said that she did. City Attorney Shaver asked Ms. Sinclair if she agreed with the results Ms. Peterson read into the record. She said yes. Ms. Sinclair said she believes she made the survey harder than it needed to be and ran out of time and that is why her numbers were on the lower side. She said that she did two Sundays and two evenings but the residential was hard to catch anyone home.

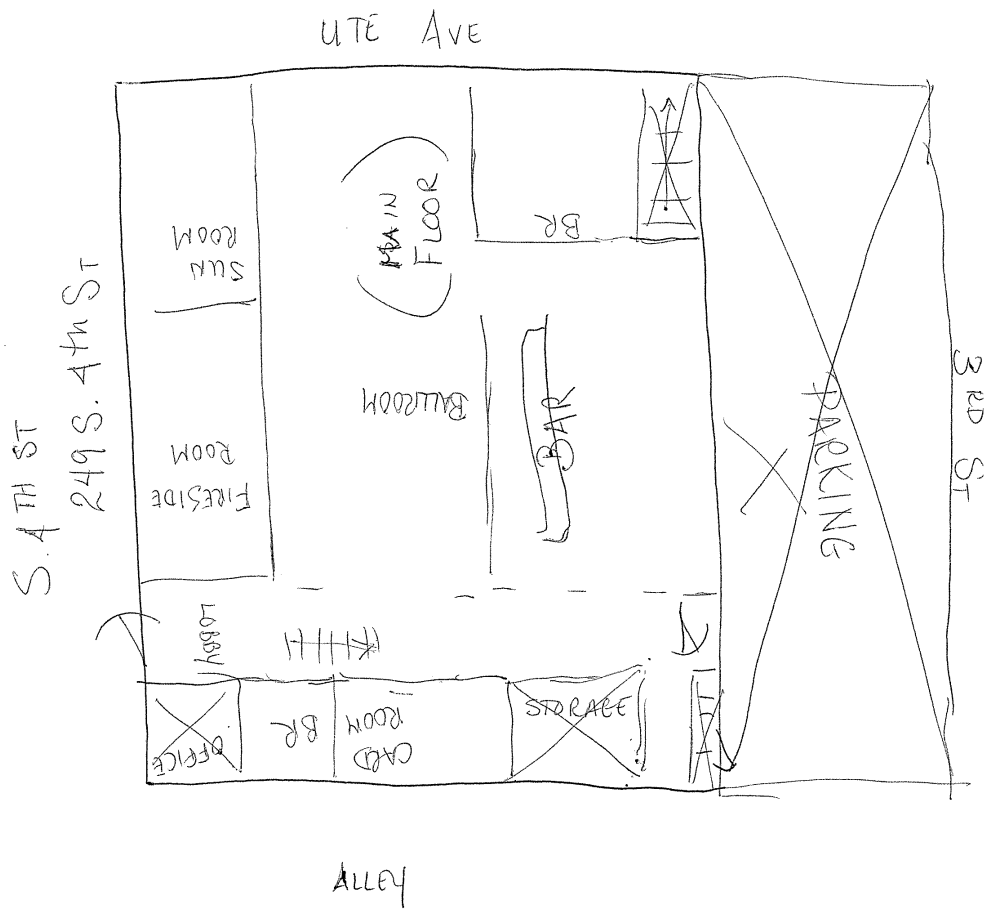

Ms. Peterson asked City Attorney Shaver and Hearing Officer Grattan if due to the nature of the next hearing with the continuance, asked City Attorney Shaver about the possibility of splitting the meeting and starting the normal agenda items at 1:00 p.m. with Hearing Officer Grattan presiding over those and then at 2:00 p.m. continue the hearing for the retail liquor store license with Alternate Hearing Officer Starritt. After a brief discussion both agreed to this. Hearing Officer Grattan said that he would offer up that he is available too if for some reason Hearing Officer Starritt wasn't.

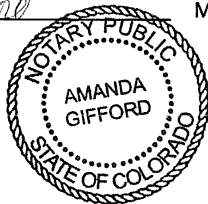

SUBJECT: Application for a new tavern liquor license by DSDJ Entertainment Inc. dba Weavers' Red Room, 103 N. 1st Street

DSDJ Entertainment Inc. filed an application with the Local Licensing Authority on June 22, 2012 for a new tavern liquor license permitting sales of alcohol beverages by the drink for consumption on the premises at 103 N. 1st Street under the trade name of Weavers' Red Room. The application and supplementary documents were reviewed, found to be in order and accepted. The applicant currently has a Hotel and Restaurant Liquor License and will surrender upon the issuance of this Tavern license. The hearing date was set for August 1, 2012. The Notice of Hearing was given by posting a sign on the property on or before July 22, 2012 and by publishing a display ad in the Daily Sentinel on July 20, 2012.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded on the North by Hill Avenue, 4th Avenue on the South, 8th Street on the East and West Avenue on the West and includes both sides of the streets as the outer boundaries. The results of that survey are as follows:

There was 1 response that had no opinion and 1 disqualified being out of the area.

There was 56 "exhibits to survey petition" that indicated 9 people refused to sign, 39 with no answer, and 8 with no solicitors posted.

No letters of opposition or counterpetitions have been filed to date.

The Grand Junction Police Department has investigated the individuals for local criminal history. They will be inspecting the property to ensure the Notice of Hearing has been posted in a timely manner. The fingerprints have been forwarded to CBI for further processing. Reports have been requested by the Grand Junction Fire Department, Mesa County Health Department, and City of Grand Junction Sales Tax Department.

The number of similar-type outlets in the survey area is as follows:

Tavern – 7 (Spring Hill Suites, Main Street Suites, ¡sabrosa! restaurante, Mesa Theater and Club, Rocky Mountain Pub, Quincy's Bar and Grill, Boomers, and Tenacious Brothers)
