Review to verify there is a firm plan in place to meet the food requirement as per the State Statute

Ms. Peterson reported that Mr. Weaver has turned into the City Clerk's office a completed application for a new Tavern Liquor License. The application is pending acceptance.

Mr. Weaver was present and said that there is legislation SB12-118, that might eliminate the 25% food requirement for hotel-restaurant liquor licenses.

Ms. Peterson copied the draft bill for both Hearing Officer Grattan and City Attorney Shaver but they only received it at the beginning of this meeting.

Mr. Weaver said he has hired a new chef and will start serving lunches and dinner but with the economy the way it is, it will be difficult to meet the 25% food requirement as the law is now.

City Attorney Shaver said his office would follow up on this and find out the final outcome of this Bill in the House. Both agreed that Mr. Weaver has acted in

good faith to resolve this matter but if this repeals the 25% food service there would be no need to do a transfer of ownership. City Attorney Shaver will update the Authority when the final bill is signed by the Governor.
