

RESOLUTION NO. 4-87

OF DECISION ON APPLICATION REQUESTING TO CHANGE,
ALTER OR MODIFY PREMISES BY
J.R. STUDEBAKER, dba VILLAGE WINE AND LIQUOR
AT 1133 PATTERSON ROAD #12, GRAND JUNCTION, COLORADO.

J. R. Studebaker, dba Village Wine and Liquor, made a request to change, alter or modify premises in which Village Wine and Liquor would be moved from space #12 and #13, to space #1 and #2 at 1133 Patterson Road. The local licensing authority, having considered the request to change, alter or modify premises, hereby finds as follows:

1. The request to change, alter or modify premises was first considered at the regularly scheduled hearing on March 18, 1987. The decision on the request was set for the regularly scheduled hearing of April 1, 1987.

2. After having examined the statutes and regulations concerning a request to change, alter or modify premises, it is the decision of the local licensing authority that Mr. Studebaker is in fact seeking a change of location.

3. This decision is based on a determination that the change sought by Mr. Studebaker has no physical connection with the present location.

4. The decision is also based on a determination that Mr. Studebaker would not be altering his original plans and specifications, but instead would be establishing new plans and specifications for a location having no physical connection with the present site.

5. It is the decision of the local licensing authority that Mr. Studebaker must apply for a change of location in compliance with Colorado law and specifically with regulation 47-128.6.

NOW, THEREFORE, BE IT RESOLVED BY THE LOCAL LICENSING AUTHORITY OF THE CITY OF GRAND JUNCTION:

That the request to change, alter or modify premises by J.R. Studebaker, dba Village Wine and Liquor, is hereby denied.
