RIVERFRONT COMMISSION REPORT - FRANK DUNN

Dr. James was unable to attend the Riverfront Meeting on October 20 because of the Parks Master Plan Meeting. Kathy Portner from Community Development took notes for us.

Item 4

LOTTERY REQUEST - TIM SCHLENVOGT

Tim Schlenvogt, Principal of Orchard Mesa Middle School, was present to request Lottery funds for the Orchard Mesa Middle School Parks Project. The project is a joint effort between the Orchard Mesa Middle School Students and Parents, Grand Junction Lions Club, School District #51, Mesa County and Grand Junction Parks and Recreation.

The park is designed to be a multiple use facility for both the school and community. The project is planned in three separate phases over five years, and the estimated total cost is \$300,000.

Tim told the Board that the parents and students have raised \$12,500.00 for the project, Grand Junction Lions have tentatively committed \$15,000.00, School District 51 \$20,664.00. They have a verbal commitment from Mesa County for \$46,000, and would like to ask the City for \$20,000.00 in Lottery Funds.

Jamie Hamilton asked Tim if this project is firm. In the past this group was not very stable after the project coordinator moved out of town. Tim told Jamie it is very stable.

Ted told the Board that School District 51 is aware of this plan and will accept responsibility for maintenance.

Keith Mumby asked the Board to contact John Leane, Mesa County Commissioner, to encourage the County to donate the \$46,000.00.

Karen Madsen asked Tim if the Orchard Mesa Lions had been contacted about the project. Tim said they haven't, but they plan to make a presentation to them and other community groups.

A motion was made by Karen Madsen to recommend to the City Council \$20,000.00 in Lottery Funds for the Orchard Mesa Middle School Sports Complex.

Seconded by Dr. James.
