RIVERFRONT COMMISSION REPORT - DR. JAMES

Dr. James told the Board he attended the May 17th Riverfront Meeting. The Riverfront Office is still in the Public Service Building, but will have to move soon.

The Old Spanish Trail plan is slowly moving forward.

Blue Heron II Trail is progressing. All of the land acquisition is final, and a trail dedication is scheduled for June 4th.

The City Parks Department is working on the trail head at South Rim Subdivision. Dr. James told Don Hobbs the Riverfront Commission is pleased with the City Parks Department maintenance of the Riverfront

A long discussion was held regarding 100 foot easements on the trail courses. Many property owners are against that large of an easement, and 30 foot easements may be adequate.

The terms of Commission Members Ken Nesbitt, Brad Loucks, Fid Braffet and Carol Hanna expire at the end of June. They are open to suggestions for nominations.
