Grand Junction Commission on Arts and Culture Minutes February 24, 2010

The regular meeting of the Grand Junction Commission on Arts and Culture was held on the above date. Chair Kat Rhein called the meeting to order at 4pm. A motion was made by Jeanine Howe, seconded by Lancer Livermont, to approve the minutes of the last meeting on January 27, 2010 as written. The motion carried unanimously.

Rob Schoeber and Debbie Kovalik updated the Arts Commission about how the various projects and job of Cultural Arts Coordinator will be accomplished following Allison Sarmo's retirement April 1. Schoeber noted that overall the City has scaled down 70 employee positions, but departments are trying to continue to provide all the same services simply with fewer employees, which is the case with the Arts Commission. Kovalik introduced Layne Whyman, who will be the liaison between the Arts Commission and the Economic, Visitor, and Convention Bureau, explaining that the VCB will be taking over production and distribution of the Commission's community cultural events calendar. Lorie Gregor was also introduced, and she will take over all the other functions of the Cultural Arts Coordinator position, except for Art on the Corner, which will be returning to the Downtown Development Authority and staffed out of that agency.

COMMISSION GRANTS: The Commission reviewed at great length the 23 applications for financial assistance to support arts and cultural events and projects in Grand Junction which had been presented the previous night. The following potential conflicts of interest were noted for the record, and these Commission members did not vote on the applications for which there might be a conflict: Melonie Buchanan – Aspen Dance Connection, Mesa State College, and Grand Junction Symphony; Gisela Flanigan – Grand Junction Symphony, Mesa State College, and KAFM Community Radio; Jeanine Howe – Mesa State College. The Coordinator noted that Mesa State College withdrew their application, having found another possible funder for the project.

Commission members discussed the merits, issues, and concerns of each organization's event or project. The suggestion was made that n order to adequately support as many worthy organizations and projects as possible, the Commission should cap the grant awards at \$4,000, and this was confirmed as the general agreement. After careful consideration and extensive deliberation, the consensus of the Commission was not to award funding to two of the projects,

due to major questions about the viability of the projects, the specific use of Commission funding, and/or their proposed budgets. A straw vote was taken on a "yes", "no", "maybe" basis to determine a relative ranking of the remaining applications. Following that exercise, the discussion centered on which projects should be awarded full funding and which projects should be award less than full funding.

The consensus of the Commission was to recommend to the City Council awarding grants to support arts and cultural events and projects to the following organizations, in the following amounts:
