The special meeting of the Grand Junction Commission on Arts and Culture was held on the above date. This meeting is the GJCAC Annual Board of Director's Planning Retreat.

Rob thanked the commission for their work and spoke to what the potential changes are for the upcoming year. The City of GJ has done a prudent job of maintaining fiscal control this year. The first model will carry that current level forward and decreases the budget by about 8%. Model two will decrease it an additional 4%. Model 3 is dependent on the outcome of the November ballot issues – if those take place it will decrease the budget by a total of 31%. He requests that we be creative as we move forward and give them any suggestions that the board may have to continue services and not be as reliant on income sources from the past.

Illene will be acting as a facilitator for our board today as we go through the strategic planning process.

Agreements that the board will agree to follow for this meeting (and possibly could be used for future meetings) – these agreements allow Illene to refocus the board based on these agreements (and the Chair in the future):

- Cell phones on vibrate/off
- Leave the meeting as needed (emergency)
- Presentations/thoughts should be concise, relevant, time-sensitive, and focused
- Avoid repetition of comments and discussions
- Prepare if presentations are planning to be made material is made available before the meeting for board review; committees can provide minutes to the board after they meet so that board members are informed of the progress and decisions that are made
- Agenda follow and honor
- Leave details to the committees and empower the committees; expectations of each committee will be made clear
- Start on time
- If you are not present, no vote/complaint; if you know you will not be present send comments/opinions to Chair

Gisela suggested that when we make presentations in the future that we be very concise and time sensitive following the "Three Minute Presentation" topic. She will email us a sample of the presentation under this theory. The job of the board and our roles within the community will be changing and the goal is to make our meetings as efficient as possible so that we can use that time for other things.
