The regular meeting of the Grand Junction Commission on Arts and Culture was held on the above date. Chair Gisela Flanigan called the meeting to order at 4:01 pm.

Change to previous minutes – Gisela would like to add a note regarding the late start time on the previous meeting due to the fact that we were signing a condolence card for Don Meyers, former commission member. The motion was made by Lancer Livermont, seconded by Gary Smith, to approve the minutes of the Commission's meeting (with that additional note) on June 23, 2010. The motion carried unanimously. Those changes will be made and then minutes sent to the City.

Champion of the Arts Committee: discussion of individuals and businesses nominated/selected as well as the process used to narrow down artist finalists to be presented today. Please see attachment provided by Lorie to the committee for details.

Commission members, after considering artist finalists, voted and selected the following artwork to be used as the Champion of the Arts Award:

- Business "Ute Canyon Morning" by David Rowe
- Individual "Storm Cloud, Bookcliffs" and "Snowy Rocks near Spruce Grove" by Noelle Goslee Smith

Melonie requested that the finalists be given a letter. Lorie said that she will have a formal letter for those that were chosen as finalists and that she will be calling those that were not selected as finalists. If commission members can wait to advertise winners until they receive an email from Lorie with appropriate press release information in the next few days (the formal announcement from the Arts Commission).

21st Century Initiatives:

Commission members looked at ideas that we can use to help promote the National Arts and Humanities Month that takes place in October. Considering the delay in starting this process for this year we are looking to find activities that can be done simply and then reconsider the activities for future years to continue to promote the arts and support this national endeavor. For this year we will focus on:

 Disseminate information to schools to promote National Arts and Humanities Month – they can send us photos/descriptions/etc. about what they did as a school to promote the month

- Media Spot
- Official proclamation from the City

The commission will then continue to brainstorm ideas throughout the year to use in the future.

Western Colorado Journeys:

Kat has developed a new magazine to be distributed on the front range of Colorado to promote Western Colorado (not just Grand Junction) – mainly focusing on art, wine, and destinations. This is a new for-profit venture that will encompass both a magazine as well as on online website/gallery where artists will be able to post and sell their work. Each city on the Western Slope will have their own section that promotes their destination. The website, partially completed, will be complete by the end of the month with an expected full-site completion of the end of November. This is intended to be a new resource for local artists to display and sell their artwork. The distribution of the magazine will be as extensive as possible on the Front Range as a free annual magazine to the consumer. First magazine will be distributed March 2011. This presentation was requested to make sure that the venture is "open" to the Commission in terms of the difference between her volunteer work with this commission and this for-profit venture.

Retreat Revisited:

Lorie presented to the Commission what exactly her job and functions are within the Parks and Recreation department as well as how that fits within the Commission and our goals. This stems from the need for the Commission members to take a more active role in our events/business since there is no longer a single person whose sole focus/duty is to coordinate the arts/culture facet. The Parks and Recreation Department would like the commission members the "face" of the arts in our community rather than a single person or staff member. This is a good time to begin to make that transition as roles/responsibilities within the Parks and Recreation department have changed. Lorie also thanked the Commission for helping with a smooth transition – from community perspective, the feedback is that they have noticed no change in how things function. The Sourcebook was successful this year and we will continue to refine how that will progress for future years. Randall suggested that the new Sourcebook be available for distribution during the Champion of the Arts/Symphony Gala reception in November. The cover art on the new book helped to recognize the previous Champion of the Arts by using their work.

Business Plan for the Commission:

Once the commission creates a framework for what our business plan will look like, Kat and Randall have agreed to coordinate this plan for us based on their expertise. This process began at the Commission Retreat and will be an ongoing process. Discussion will continue as to how to consolidate our Business Plan with our current Strategic Plan to make it efficient and effective for this Commission.

- Orchard Avenue Elementary has been awarded the Arts in Education Grant for this year Wednesday, October 6th event will be held in the gymnasium at 10:20 a.m. They are requesting as many commission members to be present at possible. Creede Repertory Theater will be performing at 10:30 a.m.; Gisela will be the official representative
- ArtSpace Open Studios Tour October 8th and 9th any Commission members that will be attending (and other events that they attend) will be asked to fill out an "assessment"

- of the event based on their funding from our grant process; Lorie will send this out via email; Lancer will officially attend but any others are welcome
- Debi suggested that we have an "adopt an event" for all of grant funded programs for Commission members so there is a personal connection with the event and the Commission is reprensented
- Legends sculpture unveiling will be held October 15 at 5:30 p.m. on 7th and Main with reception to follow
- November 1st and 2nd at 7:30 p.m. Western Colorado Chorale "South American Music Concert"; Lorie will contact them regarding complimentary tickets that should be provided as part of the grant process
- November 5th and 6th from 10:00 4:00 p.m. Mesa County Public Library Culture Fest

Grants:

We need to look for possible granting opportunities to fund the Commission on the Arts for the future; if you see/hear of any grants that we can apply for to help make this a self-funded organization; the grant that we are currently receiving from the Colorado Council for the Arts that we utilize for our granting process may have new stipulations attached to them that may limit our access to those funds; consider national and local grants as well as possible business and individual "grants"
