# FACEBOOK UPDATE:

Presentation and discussion by Felicia as the availability and usefulness of Facebook to further the mission and activities of the Commission. Some important statistics:

- 73% of Mesa County residents are registered on Facebook
- Average age of users is 38 years old
- Flowtown.com has many stats on users of social networking sites

In general this could increase our "name" to drive people to the website and post events and connect with others in the arts community. If we strive for at least 2 posts per week that is considered "active" and seems like it would be feasible. Who will manage and monitor it?

- Set up gmail account for the commission that has each of us has access to it
- Set up the Facebook page with all of us as administrators Felicia can set one up and send it out to us to look at then we can make changes and then officially announce the release of it
- QR code new technology that we might be able to include on all distributions that are "coded" so that when people use smartphone technology it will send them to directly to wherever you want it to go when they scan it; it has the capacity to drive traffic to where you want it to go

Gisela requested that we look at some other Facebook sites and let her know if you have any suggestions for the Facebook page please email Felicia or Gisela. Requests will be made of the Commission members to send out the "announcement" to as many groups as you have access to once we are live – we will also request that organizations that have been funded by the arts commission help spread the word! Goal date for going "live" is the week of November 8<sup>th</sup>.
