

ORDINANCE NO. 1542

AN ORDINANCE VACATING A PORTION OF ALLEY WITHIN THE CITY OF GRAND JUNCTION

WHEREAS, the portion of alley hereinafter described has been petitioned for vacation; and

WHEREAS, such vacation has been approved by the Planning Commission, would not deprive anyone of access to property and would not be detrimental to the inhabitants of the City of Grand Junction:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That the following portion of alley within the City of Grand Junction, Mesa County, Colorado, to wit:

A fourteen foot alley lying North of Lots 1 through 5 of Block 3 Parkland Subdivision;

and

A sixteen foot alley lying North of Lots 1 through 10 Block A Park Terrace Subdivision

be, and the same is, hereby vacated subject to easements for existing utilities.
