ADDENDUM NO. 1

RE: Official Visitor Guide RFP-4570-19-SH

Offerors responding to the above referenced solicitation are hereby instructed that the requirements have been clarified, modified, superseded and supplemented as to this date as hereinafter described.

Please make note of the following:

1. Question: Cover list as 4/4 bleeds plus a Satin Touch UV, will a Satin Touch AQ be acceptable?
Answer: Please see Section 4.2.3.1, The cover is a Soft Touch UV, not a Satin Touch. To accomplish the look specified, it is recommended the cover be printed on a sheet-fed press with coating applied offline.
2. Question: Text stock is too light to apply a coating, i.e. Satin Touch AQ, is that acceptable?
Answer: Please see Section 4.2.3.2. The text stock does not require an offline coating; it should be provided as specified as a 60# No. 3 Matte Text.
3. Question: The specifications for the cover is for offline flood soft touch UV, can do inline soft touch UV. Please let me know if that is acceptable?
Answer: You may submit anything that is close or comparable to what is requested in the RFP. It is very important that samples are included with all submissions.
4. Question: The quantity is 65,000 as per specs. All 3 quantities 65,000; 100,000 and 130,000 are listed on the response form.
Answer: The expected order quantity is 65,000, but there is a possibility the order could go as high as 100,000 and up to 130,000. Please quote all three quantities as requested on the Response Form.
5. Question: If the proposal will be submitted in electronic format, how can we include samples with submission?
Answer: Samples need to be submitted in hard copy prior to the date and time of opening.
6. Question: Do we send hard copies of the bid to you with samples, or just the samples?

Answer: The bid will be submitted electronically. The samples will be sent separately to:

7. Question: Can you confirm the RFP is open to out-of-state vendors, referring to section 4.2.6.3 to include travel costs for 2 for required press check?

Answer: Everyone is invited to respond to the RFP. Quoted prices will need to include travel costs as noted in Section 4.2.6.3.


8. Question: I have a question about the spot varnish, is it on all 3 body forms? It wouldn't be on the cover as you as asking for soft touch UV.

Answer: There is no varnish required in the body, only soft touch UV on the cover.
