## SUBJECT:

Selection of members for the 2020 Comprehensive Plan Advisory Committee (CPAC)

## **EXECUTIVE SUMMARY:**

The City will be conducting the 2020 Comprehensive Plan update over the next 18 months. As a part of this effort, a Comprehensive Plan Advisory Committee (CPAC) will be established to provide input on the Plan. City Council should consider appointing 12 to 15 people from a list of applicants to serve on this committee.

## **BACKGROUND OR DETAILED INFORMATION:**

The City of Grand Junction is beginning the process of updating the City's Comprehensive Plan that was last adopted in 2010. The Comprehensive Plan is a long-range plan that looks at where and how the city will grow over the next 20 years. The update will include planning for residential and commercial growth and needed services and infrastructure (parks, utilities, roads, police, fire, etc.), potential changes to the City's growth boundary, identifying risks and vulnerabilities of natural and human-caused hazards and identifying goals, strategies and actions that reflect the community's values and vision.

The City will be conducting the 2020 Comprehensive Plan update over the next 18 months. As a part of this effort, a Comprehensive Plan Advisory Committee (CPAC) will be established to provide input on the Plan. City Council should consider appointing 12 to 15 people that represent a variety of perspectives from a list of applicants to serve on this committee.

The Comprehensive Plan Advisory Committee will serve as a sounding board, meeting at key points during the project to discuss overall planning direction, review project deliverables, vet ideas and help promote community involvement. This advisory committee may include elected/appointed officials, representatives of community organizations, business owners, residents and other stakeholders. Committee members will be asked to attend 5 to 7 meetings during the planning process as well as to attend public outreach events. Formal appointment of the CPAC has been scheduled for the February 6th Council Meeting.

The consultant on the Comprehensive Plan, Houseal Lavigne, recommends appointing a committee of 12 to 15 members of which members should be considered for their geographic representation as well as expertise and interests. Members with experience in some or all of the following areas may be helpful in this process:

- 1. Economic/Financial/Business
- 2. Residential or Commercial Development
- 3. Real Estate Commercial and/or Residential
- 4. Planning/Landscape Architecture/Urban Design
- 5. Parks/Open Space/Trails
- 6. Neighborhood Organizations
- 7. General Interest/Citizen/Neighborhood
- 8. Housing
- 9. Senior-Aged Residents
- 10. Millennial-Aged Residents
- 11. Transportation
- 12. Member of Planning Commission

Staff solicited for approximately 10 days letters of interest from the community. Staff received 44 letters of interest by the deadline. In addition, staff and consultant recommend including a representative from both the City of Grand Junction Planning Commission as well as the Mesa County Planning Commission which brings the total to 46 people to be considered for appointment to the advisory committee. The list of Applicants is attached and formatted in the following ways; 1) alphabetical by first name, 2) area of experience and 3) the neighborhood area of the City they either live or work based on the address they gave in their letter of interest. Included in the attachments are the letters of interest received by staff.

There will be many other opportunities besides membership on the CPAC for city business leaders, applicants not selected for CPAC and all other community members to provide input and participate in the 2020 Comprehensive Plan update. These opportunities include a "Community Workshop" to inform participants of the planning process through unique exercises and therefore allowing the City to better understand local views, opinions and concerns about City's areas; a "Business and Property

Owner's Workshop" that specifically invites these groups to dialogue and provide feedback; as well as other traditional methods like focus groups and small group meetings. In addition there will be outreach that may include flyers, posters, postcards, events, "Do-it-yourself" kits allowing neighborhood associations and other groups the opportunity to host their own workshops.

## **FISCAL IMPACT:**

No direct fiscal impact.

## **SUGGESTED ACTION:**

Review and discuss individual applicants and select 12 to 15 to serve on the Advisory Committee (CPAC). Formal appointment of these committee members has been scheduled for the February 6, 2019 City Council meeting.

Hello Dave,

I am writing to express interest in influencing the direction of the Comprehensive Plan. My goals would include creating policies to drive the city and valley towards more densification, towards a comprehensive trails policy and, towards educating the public in areas commonly known as Urban Myths (high density, traffic, overcrowding, traffic, crime, traffic, and pollution) yes I know I said traffic 3 times but it is a seriously misunderstood issue in our valley.

I would like to develop the idea of the "Trail Transect". I have been working on this from time to time trying to develop a model for building the right kind, type, and size of trail in the right places. We have wonderful "interstate trails" aka the River Trail. And we have great hardcore mountain bike trails built by COPMOBA, which are like residential drives. But there is so much middle ground that lacks definition. We need to more appropriately connect from the residential drive to the interstate. When we build streets we wouldn't dare think about connecting a driveway or residential street directly to the interstate highway. But that's what we often do in our trail system. We can do better. The Trail Transect would create an ever intensifying and escalating classification for trails around the valley so that we connect the COPMOBA trail to a residential collector trail, to a minor arterial, to a major arterial to the Parkway, on to the interstate trail. From barely developed native soil surface, to hard pack, to ¼ minus, to asphalt, to 10 foot wide concrete. We shouldn't over-build a trail nor should we under-build a trail. But how do we know what is what? Anyway, all of this could be worked into the Comp Plan.

I would like to improve the Plan with ideas that are espoused by the Urban Land Institute in

order to promote business growth and development. I would like to encourage ideas from the Congress for the New Urbanism in order to promote a more walkable and "sitable" community.

Having worked on over 100 projects on the Western Slope of Colorado I would bring my experience in mountain towns such as Breckenridge and Avon to our valley in a way I think would promote more tourism and would feel more welcoming to tourists. Thank you for your consideration in this.


