ORDINANCE No. 1938

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION, COLORADO.

A parcel of land in the Southeast Quarter of Section 25, Township 1 South, Range 1 West, Ute Meridian; Beginning at a point on the North right of way of Highway 50 which bears South 55°04'27" East 1165.40 feet from the Northwest Corner of the Southeast Quarter of Section 25; thence South 69°29' East along said right of way 367.07 feet; thence North 794.73 feet to the centerline of B.5 Road; thence North 89°57'00" West along the centerline of B.5 Road 343.79 feet; thence South 666.38 feet to the point of beginning. Together with B.5 Road right of way on the North;

be and the same is hereby annexed to the City of Grand Junction, Colorado.




