MINUTES OF FIREMEN'S PENSION BOARD

June 13, 1963

A meeting of the Firemen's Pension Board was held in the Conference Room at the City Hall with the following members present: City Manager Joe Lacy, City Attorney Jerry Ashby, City Clerk Helen Tomlinson, Firemen R. T. Mantlo, Jack Schmidt and Orville Hannigan and City Finance Director Charles E. Green.

The purpose of the meeting was for the board to seek to come to a decision regarding the request for temporary retirement by Mr. Hoyt Brown.

City Attorney Ashby pointed out that he felt the board should consider two questions as they sought to make a decision. The questions are as follows:

1. Was Mr. Brown disabled while in the performance of duty or by reasonable service in such department.
2. Was Mr. Brown so disabled to prevent him from resuming his duty with the department at this time.

Alternative solutions available to the Board in regards to Mr. Brown's request were then listed on the chalkboard and are as follows:

1. Deny a pension.
2. Place on temporary disability.
  - (1) Retroactive to October 15, 1962.
  - (2) Full pay at \$396.00 per month.
  - (3) Period of one year, however, Board can ask individual to have a periodic medical examination and if at any time the disability has been overcome, the pension could be terminated and the individual asked to return to work.
3. Grant pension.
  - (1) Retroactive to October 15, 1962.
  - (2) One-half salary - \$198 per month.
  - (3) Can ask individual to have a periodic examination and if at any time the disability has been overcome, the pension could be terminated and the individual asked to return to work.
4. Make an offer of temporary disability.
  - (1) Effective June 13, 1963.
  - (2) Full pay at \$396.00 per month.
  - (3) Period of one year with medical examination required at the end of the year or sooner if board so desires. If at any time the disability has been overcome, the pension could be terminated and the individual asked to return to work.

After much consideration and discussion by the board of the various alternatives, a motion was made by Mr. Mantlo and seconded by Mr. Hannigan to place Mr. Brown on temporary disability retroactive to October 15, 1962, (Alternative No. 2). The motion died because of a tie vote. (3 Ayes - 3 Nays)

A motion was then made by Mr. Mantlo and seconded by Mrs. Tomlinson to make an offer to Mr. Brown of temporary disability effective June 13, 1963, (Alternative No. 4). The motion also stated that should this offer be rejected the board automatically denies Mr. Brown a pension. Motion carried.

It was moved and seconded that the meeting be adjourned.
