March 13, 1972


Attendance: Cecil Campbell, Richard Gray, Harvey Rose, and William Manchester.

A letter from Fireman William E. Mc Curry (Step 14 F, 665.00/month) was received and noted in which Fireman Mc Curry requested disability retirement from the Grand Junction Fire Department.


A letter from Oliver E.K. Hall M.D. Orthopedic Surgeon supporting Fireman Mc Curry's claim of disability was read.

Motion by William Manchester, seconded by Harvey Rose that Fireman Mc Curry be granted a disability pension effective March 16, 1972 at $\frac{1}{2}$ pay (\$332.50/mo.). The escalator clause for future raises of department salaries will apply. In addition the board may request 18 months from now to determine if the disability still exists. Passed Unanimously.

I would like to refer to the Legislative Board for consideration of the following amendments to the Statutes of the State of Colorado, Article 10, Section 10-1-101.

The amendment is one to be junior relieved from an accident to the person and in connection with, and finally surgery in November 1971, to be from the physical pressure caused by a ruptured aortic aneurysm.

The possibility of a person being in full duty as a fireman is in doubt at this time.

To afford the citizens of Grand Junction the full protection they expect and deserve from a fully manned and healthy fire dept.

The amendment is requested to be effective as of March 1, 1972.

This is to certify that Mr. William E. McCurry has been under my care for an injury of his neck and that he had surgery on 11-22-71 at which time a cervical disc was excised and fused.

The patient is not ready to return to active duty as a fireman now, and perhaps he will not be able to perform the usual duties as fireman, particularly such things as dragging hoses and other strenuous activities, and he may also be restricted in his ability to perform activities requiring him to move his head, such as looking up in climbing a ladder.

I approve of his request for retirement from the Fire Department.
