AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION, COLORADO.

A tract of land located in a part of the Southwest Quarter of the Northwest Quarter of Section 36, Township 1 North, Range 1 West of the Ute Meridian, being more particularly described as follows: Commencing at the Northwest Corner of the South Half of the Northwest Quarter of said Section 36; thence South 00°07'49" West along the West line of the Southwest Quarter of the Northwest Quarter of said Section 36 a distance of 352.85 feet; thence South 88°23'56" East 50.02 feet to the TRUE POINT OF BEGINNING; thence continuing South * East 13.96 feet; thence along the arc of a curve to the left whose radius is 130.00 feet and whose long chord bears South 55°23'36" East 124.90 feet; thence North 84°06'14" West 121.25 feet; thence North 88°23'56" West 434.79 feet; thence North 00°07'49" East 60.02 feet to the TRUE POINT OF BEGINNING;


