GRAND JUNCTION CITY COUNCIL MINUTES OF THE REGULAR MEETING

February 6, 2019

The City Council of the City of Grand Junction convened into regular session on the 6th day of February, 2019 at 6:00 p.m. Those present were Councilmembers Chris Kennedy, Duncan McArthur, Phyllis Norris, Duke Wortmann, and Council President Barbara Traylor Smith (via phone). Councilmembers Bennett Boeschenstein and Rick Taggart were absent. Also present were City Manager Greg Caton, City Attorney John Shaver, City Clerk Wanda Winkelmann and Deputy City Clerk Janet Harrell.

Council President Traylor Smith called the meeting to order. Councilmember McArthur led the Pledge of Allegiance which was followed by an invocation by Landmark Baptist Church Pastor Tom Barlament.

1. Resolutions

a. Resolution Authorizing a City Council Acting President Pro Tem

The Mayor and the Mayor Pro Tem will both be absent from the City at the same time and the City Council determined the appointment of an acting Mayor Pro Tem is necessary.
