AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION, COLORADO.

WHEREAS, on the 6th day of February, 1985, the City Council of the City of Grand Junction considered a petition for the annexation of the following described territory to the City of Grand Junction; and

WHEREAS, the City Council determined that said territory was eligible for annexation and that no election was necessary to determine whether such territory should be annexed as the petition was signed by the owners of one hundred percent of the territory petitioned for annexation;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

That the property situate in Mesa County, Colorado, and described to wit:

Beginning at the Southeast corner of Lot 7, Block 6, Fairway Park Subdivision, thence North and Northwest along the East line of said Block 6 to the Northeast corner of Lot 5 of said Block 6, thence Southwesterly along the Northerly line of said Lot 5 to the Northwest corner of said Lot 5, thence West to the centerline of Golfmore Drive, thence Northwesterly along said centerline to the intersection with the centerline of Club Drive, thence Westerly along the centerline of Club Drive to the intersection with the West line of Section 36, Township l North, Range l West, Ute Meridian, thence South along said West line to a point West of the Southwest corner of Lot 2, Block 3, Fairway Park Subdivision, thence East to said Southwest February 29, corner of Lot 2, thence East to the Southeast corner of Lot 4, Block 5 of said Fairway Park Subdivision, thence East to the centerline of Golfmore Drive, thence North along said centerline No. 239 Book No. 11 to a point West of the Southwest corner of Lot 7, Block 6, Fairway Park Subdivision, thence East to said Southwest corner of Lot 7, thence Southeasterly along the Southerly line of said Lot 7 to the


