The following sum shall be appropriated to the Administrative Services Department, said sum to be derived from charges to various departments of the City for General Liability and Fire Insurance.

For Personnel Division in the Administrative Services Department \$1,043,489 Revenue from General Liability and Casualty Fund \$1,043,489
