Beginning at a point NO0°01'E 484.87 feet and S89°53'E 40.0 feet from the Southwest corner of Section I, Township I South, Range I West of the Ute Meridian, thence S89°53'E 619.77 feet, thence NO0°01'E 145.0 feet, thence N89°53'W 619.77 feet, thence S00°01'W 145.0 feet to the PO.B. The West 10.0 feet thereof to be dedicated for road purposes.
